**AGREEMENT**

THIS AGREEMENT dated \_\_\_\_\_, 2019, (“Effective Date”) is by and between Roger Nault, residing at 16 High Ridge Rd, Brookfield, CT 06804, Ronald Nault, residing at 21 Bayberry Ln, Guildford, CT 06437, Darlene P. Nebinger, residing at 332 Quaker Farms Rd, Oxford, CT 06478 and Michelle DeBenedetto, residing at 377 Carriage Dr., Southbury, CT 06487, and the Town of Carmel, New York, a municipal corporation with its principal offices at 60 McAlpin Avenue, Mahopac, NY 10541 (hereinafter referred to as “Town”).

WHEREAS, the Owner is currently owner in fee simple of the property located at 2-6 Rogers Land, Town of Carmel Tax Map No. 54.8-1-55, located within the Town of Carmel, Putnam County, New York (“Subject Property”); and

WHEREAS, the Subject Property is currently improved with four (4) single family residences; and

WHEREAS, the undersigned parties acknowledge and agree that the current configuration of the Subject Property with four (4) single family residences on a single parcel is a non-permitted use under the provisions of the Town Code of the Town of Carmel; and

WHEREAS, the parties, by the execution of this agreement, acknowledge the mutual intent to return the Subject Property to original lot lines comprised of four (4) single family residences on three (3) lots as shown and demonstrated on Exhibit “A” to this agreement; and

WHEREAS, the parties, with full advice of counsel, to freely and voluntarily enter into this Agreement; and

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED BY AND AMONG THE PARTIES AS FOLLOWS:

1. The Town of Carmel shall commence an action/or special proceeding pursuant to New York Town Law §268 for the sole purpose of returning the Subject Property to original lot lines as shown and demonstrated on Exhibit “A” to this agreement.

2. The Owner hereby agrees to have its counsel accept service of all papers, pleadings and process in the referenced action/proceeding and further agrees that it will institute no defenses, procedural or substantive, within the referenced proceeding, provided that all relief sought therein is for purposes of returning the Subject Property to its original lot lines as agreed herein.

3. The Owner shall be responsible for the payment of all legal fees incurred by the Town in drafting of this Agreement and matters related thereto, as well as the commencement and prosecution of the referenced proceeding pursuant to Town Law §268, as well as the costs and disbursements incurred therewith. At the time of the execution of this agreement, Owner shall pay to the Town the sum of \$7,500 as the estimated costs and legal expenses to be incurred in connection with this matter. The parties acknowledge and agree that this figure shall be in no way deemed to be a cap or limit on the reasonable legal fees incurred by the Town in this matter but rather represents an estimate at the time of the execution of this Agreement.

4. Upon conclusion or prior to the conclusion of the reference proceeding pursuant to NY Town Law §268, the Owner, at its sole cost and expense shall be responsible for the following:

A. Providing individual water supply in accordance with the rules and regulations of the new York State Department of Health, the Putnam County Department of Health as well as chapter 151 of the Town of Carmel Town Code to each of the four existing dwellings existing on the Subject Property.

B. Installation of a fire hydrant on the Subject Property.

C. Providing individual wastewater/sewer disposal service in accordance with the rules and regulations of the New York State Department of Health, the Putnam County Department of Health as well as Chapters 119 and 120 of the Town of Carmel Town Code to each of the four existing dwellings existing on the Subject Property.

5. The Owner hereby acknowledges that the return to original lot lines for the Subject Property as contemplated by this Agreement and the referenced proceeding pursuant to NY Town Law §268 will in fact result in a modification of the Town of Carmel Assessment Rolls for all purposes, including but not limited to, overall valuation and special district assessments. Owner hereby agrees to waive any objection to those Assessment Roll modifications which result in the separate individual valuation of each parcel upon the Subject Property being returned to original lot lines. It is further acknowledged that said assessment roll modifications shall also include but

not be limited to the individual assessment of each of the three parcels for purposes of Carmel Sewer District #2 capital and operations and maintenance assessments, and Carmel Water District #2 capital and operation and maintenance assessments, as well as Carmel Fire Protection District #3 assessment and Carmel Garbage District assessments. However, nothing herein shall be deemed to limit or impair Owners' rights under Article 7 NY Real Property Tax Law.

6. Should any provision of this Agreement be declared illegal, unenforceable or void by any court of competent jurisdiction, in whole or in part, and cannot be modified to be enforceable, such provision shall immediately become null and void leaving the remaining

provisions of this Agreement in full force and effect.

Supervisor Schmitt explained that the Change Order was initiated by a delay caused by difficulties that the contractor was having with service connections to the new water main. There is no monetary impact involved.

**PUBLIC COMMENTS - AGENDA ITEMS**

Norman Marino inquired about the bidders in connection with the awards for the air conditioning unit and the supply of chemicals for the wastewater treatment plants.

Supervisor Schmitt stated that he would arrange for the information to be provided to him.

Councilman Barile added that the bids were discussed at the prior Work Session with the backup documentation posted on the Town’s website. Discussion ensued regarding the Town’s bidding process.

John Butler inquired about the Petition for Change of Zoning filed by Centennial Golf Club of New York, LLC, and asked to be provided with a copy of the petition as it was not posted on the website.

Legal Counsel Gregory Folchetti explained that he did not believe that the petition was on the agenda at a prior Work Session as the Town Board is not discussing it. Their obligation under the Town Code is to refer the matter to the Planning Board.

Mr. Butler inquired what the petition entails.

Legal Counsel Folchetti explained that the applicant is requesting a zone change that would allow for a cluster of 90 single-family homes on one of the portions of the course.

Mr. Butler expressed his frustration with regard to the possible addition of 90 single-family homes in the area and a brief discussion followed.

(Cont.)

Mr. Butler referenced the resolution authorizing the advertisement for bids in connection with the rehabilitation and repairs of the water storage tanks. He stated that he read the report with regard to the Town's water storage tanks which identified three emergency work items assessed to the Everett Road storage tank. Mr. Butler spoke about the emergency items and expressed his extreme concern. He asked if there was any action taken with regard to these items.

Councilman Schneider indicated that there was no action taken yet. He pointed out that there are twelve emergency items included in the report and that the advertisement for bids was authorized in order to streamline the repair of the items all at once as quickly as possible.

Mr. Butler noted the seriousness of the items and asked when the work will be performed.

Legal Counsel Folchetti estimated the work to be done sometime during the course of the summer.

#### **TOWN BOARD MEMBER COMMENTS - AGENDA ITEMS**

No member of the Town Board wished to comment at this time.

#### **PUBLIC COMMENTS - OPEN FORUM**

Norman Marino expressed his disagreement with the Town Board's policy regarding a three minute limit on public comments at their meetings.

Mr. Marino readdressed his comments presented at previous meetings in connection with the recent authorization for the purchase and installation of video system equipment at Town Hall and reiterated his contention that the cost was exorbitant. Mr. Marino stated that he was advised that the list of equipment included in the bid specifications was created by the vendor who was ultimately awarded the contract. He commented that this vendor should not have been allowed to submit a proposal and spoke about his issues with the choice of vendors chosen by the Town to be mailed the Request for Proposals. Mr. Marino went on to ask which of the current equipment has required repairs and he questioned the actual need for the equipment replacement.

Supervisor Schmitt explained that the list of proposed vendors for this project was obtained from Westchester County in connection with their projects. Discussion regarding the process in which the proposals were solicited was held.

Dave Nichols expressed his opposition to the possibility of expending taxpayer funds to eradicate the Canadian geese around Lake Mahopac again. He commented that there are other options available to keep them away and that the geese droppings are only posing a problem for a few residents.

Supervisor Schmitt stated that the Lake Mahopac Advisory Committee brought the geese depredation issue to the Town Board for consideration and that the matter was scheduled to be on the next Work Session agenda. Discussion followed regarding alternatives methods to control the geese population as well as New York State Department of Environmental Conservation's recent approval of the stocking of additional sterile carp for weed control in Lake Mahopac and the removal of the sunken island from Lake Mahopac.

Mr. Butler readdressed the Petition for Change of Zoning filed by Centennial Golf Club of New York, LLC. He stated that he was provided with a copy of the petition and based upon his review, considered the request significant. Discussion regarding the petition was held.

(Cont.)

Mr. Butler concluded that the petition refers to two or three attachments which were not affixed to the submission. He noted that one of attachments is the site map.

Councilman Barile questioned how the petition could be moved ahead without the referenced attachments. He suggested that the Town Board postpone forwarding the petition to the Planning Board. The discussion held regarding the matter resulted in the following motion.

On motion by Councilwoman McDonough, seconded by Councilman Barile, Councilman Schneider and Supervisor Schmitt, with all members of the Town Board present voting "aye", Resolution #7 (Resolution Pursuant to Carmel Town Code §156-76) was rescinded as passed and adopted.

**PUBLIC COMMENTS - OPEN FORUM**

Mr. Marino addressed the stocking of carp in Lake Mahopac and inquired if non-sterile carp could be added. They would reproduce, thereby alleviating the need to purchase new ones.

Councilman Barile explained that the fish must be approved by the New York State Department of Environmental Conservation. They monitor the types and amount of fish in the lake. Discussion followed.

Jean Hopper inquired about the American Legion Hall's longstanding sewer problem on Buckshollow Road which has caused them to be without a bathroom facility for several years.

Supervisor Schmitt reported that there is a meeting scheduled for Friday in connection with the matter. He stated that he was hopeful that this time the problem between the two property owners will be resolved. Discussion was held.

Mr. Butler, on behalf of a recently formed Carmel Water District #2 Facebook group, asked if there were any discussions with regard to a recommendation made calling for the construction of a dedicated water line to Putnam Hospital Center.

Supervisor Schmitt stated that there have not been any discussions.

Members of the Town Board indicated that they would be in favor of the project if the hospital paid for the water line independently. Councilman Schneider stated that he would follow up with representatives from Putnam Hospital Center.

Mr. Butler asked if the grant filing dates will be met in connection with the slated improvements to the facilities in Carmel Water District #2.

Supervisor Schmitt stated that they would be. A brief discussion resulted.

Mr. Butler inquired if the Town Board would be amenable to the formation of an ad hoc committee consisting of residents from Carmel Water District #2 and a couple of the members of the Town Board which would allow the residents to be a part of the process.

Members of the Town Board spoke in favor of the implementation of such a committee and discussion was held.

(Cont.)

Mr. Butler questioned the scheduled paving of Route 52 in the hamlet of Carmel.

Supervisor Schmitt stated that he was advised by the contractor for the project that the paving is scheduled to commence in the beginning of June. Discussion was held.

Mr. Butler referenced the New York City water usage allotment overage rate charged to residents in Carmel Water District #2 being three times the initial rate and asked if it is adjusted on an annual basis.

Legal Counsel Folchetti explained that New York City calculates the entitlement rate on a retroactive basis and imposes the excess rate which is actually about 2.9 times the initial rate. Discussion regarding the calculation process followed.

Mr. Marino asked if the Town of Carmel can tax New York City's property retroactively.

Legal Counsel Folchetti explained that the two issues involve two different enabling statutes. The City Administrative Code is how the City charges the Town for water use and the Real Property Tax Law is how the Town taxes the City. They are not applied the same way. Discussion ensued.

#### **TOWN BOARD MEMBER COMMENTS - OPEN FORUM**

Councilwoman McDonough urged residents to reply to the installation notices left by the contractor with regard to the Town's water meter replacement project.

Supervisor Schmitt stated that residents who do not reply will receive a letter and a telephone call from him.

Councilwoman McDonough commented that the Carmel Farmer's Market commenced this past Sunday at Town Hall and proved to be a great success. The Farmer's Market will continue on Sundays through August 25<sup>th</sup> from 9:00 a.m. to 1:00 p.m. and the Department of Recreation and Parks is seeking additional vendors. Discussion followed.
