# THIMM, KARL & JANIS - 232 EAST LAKE BLVD - TM - 65.17-1-15 - CONSTRUCT DOCK AND BATHHOUSE

Mr. Carnazza said all necessary variances were granted by the Zoning Board of Appeals and are noted on the plat. They have also been in front of the ECB, they are working with the DEP as we speak.

Mr. Franzetti said the ECB has granted them a wetland permit. The application encompasses to install a 20ft x 15ft bathhouse and a 300sf dock on Lake Mahopac adjacent to the referenced property; all of the site improvements include patios and a rain garden. All of the variances have been approved, all prior engineering comments have been addressed with the exception that they are still working with the NYC DEP designated main street area to get there SWPPP approval. According to the applicant there are two permits that were granted on January 21st, 2016, the applicant has submitted an application to the Putnam County Highway Department so that permit is also in progress.

Mr. Franzetti read Mr. Cleary's memo which stated the Planning Board referred this application to the ZBA and ECB. The ZBA granted them the necessary variances on September 24th, 2015, the ECB granted a wetland permit on January 21st, 2016, the SWPPP is pending review from the NYCDEP and the applicant has filed for a driveway permit with the Putnam County Department of Highway. Mr. Cleary also recommends a public hearing be scheduled on this application.

Mr. Giannico asked if we can schedule a public hearing without the SWPPP in place.

Mr. Carnazza said yes you can.

Mr. Paeprer asked if any of the board members had any questions. He said to schedule a public hearing.
