Re: Change Order #1- Contract C238- Long Pond Road Improvement District Dedication

Contract C238, the Long Pond Road Improvement District Roadway Reconstruction Project, was awarded to Landscape Unlimited, Inc, on 1 May 2017.

Construction under the contract is currently approximately fifty (50) percent complete.

Precipitation during April and May 2017 (3.35" and 3.6" respectively) has been much closer to the annual average (3.94" and 3.85" respectively) than in either 2016 or 2015 (2.35"/3.6" and 0.96"/2.26" respectively).

During the course of routine construction inspections with the Town Highway Superintendent it has become evident that the proposed elevation for Pleasant Road is inadequate under normal precipitation conditions. Mr. Simone has requested that the road elevation be increased beyond that proposed. JRFA has added one half foot to the road profile, along with the drainage swale and culvert crossing to divert the runoff.

Neither the additional fill nor the culvert piping is covered under the existing contract. The quantity of fill required for this change in profile is an additional 100 cubic yards; the culvert piping requirement is approximately 60 LF. The unit price for fill is \$100.00 per cubic yard; the unit price for 12" dimeter culvert is \$100.00 per linear foot. At these unit prices the additional fill will cost \$10,000.00 and the culvert will cost \$6,000.00. The total cost of the proposed Change order is therefore \$16,000.000.

The Engineering Department recommends that the Board approve the attached Change Order #1 and authorize the Supervisor to sign the same.
