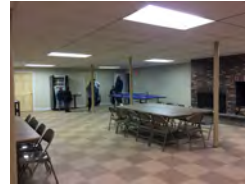

**Re:** Aerator and Fountain installation at Lake Casse Park District

As the Board is aware, in the past, the Lake Casse Beach was forced to close by order of the Putnam County Department Health because of water quality concerns. In an effort to mitigate these water quality problems, we investigated the installation of an aeration/fountain system. We received the following quotes (copies of the quotes are attached):

<u>Contractor</u>	<u>Total Bid Price</u>
The Pond and Lake Connection	\$5,267.19
Living Water Aeration	\$5,307.00
The Pond Guy	\$8,683.93

We note that both the Living Water Aeration and The Pond Guy proposals do not include installation, while the proposal from The Pond and Lake Connection does. In addition the Pond and Lake Connection has sufficiently performed services for the Town in the past.

Based upon the pricing, we recommend that the project be awarded to The Pond and Lake Connection for \$5,267.19. The cost for electrical work by a Licensed Electrician is \$1,500.00 for a total cost of \$6,767.19. As per the attached the Lake Casse Park District has sufficient funds for this work.

I respectfully request that this matter be placed on the next available work session for discussion.

## Why pond depth matters

The deeper a diffuser plate is placed in your pond, the more area it can effectively aerate. Shallow ponds, or ponds with irregular shapes & bends, require more diffuser plates per surface acre.
