Note that Penflex recommends that the Town contribute the full amount budgeted for each Program in 2015, and to budget the same amount for 2016. For more details regarding the change in contributions for each specific program, as well as a five-year projection of required contributions, please refer to the Special Commentary and Exhibit VII of each Annual Report.

The chart below details the funded ratio of each program. In calculating the annual cost of the program, the goal is to approach a 100% funded ratio over time. We will continue to monitor the program's funding progress and advise the Town if there is any reason for long or short-term concern.

2015 REQUIRED CONTRIBUTION

As reported in last year's Annual Report, the minimum required Trust Fund contribution to be made in 2015 is \$142,515. However, we suggest the Town contribute the full amount budgeted.

2016 REQUIRED CONTRIBUTION

The minimum required contribution due to be paid into the Trust Fund in 2016 is \$158,021.

The contribution due in 2016 is \$15,506 more than the contribution due in 2015. There were several things that occurred during 2015 that contributed to this increase:

- (1) An actuarial investment loss during 2014 the assumed rate of investment return is 6.00%, while the actual return in 2014 was 0.17%. This caused contributions to increase by roughly \$11,000.
- (2) A significant increase in the participation of the volunteers 13 new volunteers earned 50 points for the first time in 2014. This resulted in an overall increase in participation from 126 to 135 participants. This is the 2nd consecutive year in which participation increased there were 123 participants as of 12/31/2012. The impact of these 14 additional firefighters on the contribution was roughly \$11,000; however, other changes in participation (deaths, terminations of existing members) made the actual increase less. Regardless, this was a significant factor in the change in contributions.
- (3) More firefighters are attaining the entitlement age and remaining active to earn additional service credit. This component of the contribution increased by roughly \$3,000.

Offsetting these three factors was the fact that the Town made an excess contribution of \$38,094 in 2014. This, along with other changes in participation noted in #2 above, served to dampen the increase.

The Town should be aware that we expect the post-entitlement age component of the cost to increase slightly in the future, and there were additional new firefighters that joined in 2014 that earned 50 points, but were not yet age 18. Therefore, we expect that future contributions are likely to be higher and the Town should keep the budgeting \$175,000 annually.

INVESTMENT RETURN AND FUNDED RATIO

Calendar year 2014 marks the second consecutive year in which the investment return on the Trust Fund assets failed to meet our long-term assumption of 6.00%. The Town should keep in mind just that — this is a *long-term* return assumption. With that being said, we continue to be concerned about the impact of short-term market volatility on the annual returns and future contributions. Penflex and the RBC staff have had, and will continue to have, many discussions

about the long-term outlook of returns based on the Investment Policy adopted by the Town Board. Our transition to the lagged contribution approach will help the Board prepare and budget for contribution increases, but will not prevent them. We suggest reviewing the current investment policy with RBC and contact us with any questions about the long-term costs of the Program.

The program's funded ratio is 88% as of 1/1/2015, a decrease from 90% as of 12/31/2013 and 92% as of 12/31/2012 (note we changed the valuation date from an end-of-year to a beginning-of-year to facilitate the lagged contribution approach). The funded ratio has decreased over the past two years due to the actuarial investment loss and also the increase in participation. We will continue to monitor the funded ratio for the Town. We suggest the Town contribute the full amount budgeted in 2015 to further strengthen the program's funded status.

SPECIAL NOTES

Theodore Finney reached the entitlement age and commenced monthly payments on 4/1/2014. James Peterson was eligible to commence payment on 12/1/2014, but has not been located to this point and payments have not begun. The payment he was owed in 2014 has been held as a payable from the program assets. We have recently sent additional correspondence to a newly provided address.

Non-vested participants James Egan, Alexander Joachim & Michael Stanley are no longer active members of the Fire Department; consequently, their accrued service award and service credit have been completely and permanently forfeited as of December 31, 2014.

Non-vested participant Julio Vallejo has failed to earn 50 points for 4 consecutive years. If he fails to earn 50 points in 2015, he will forfeit his participation as of December 31, 2015.

Charles Brower was reported to be on military leave during 2014. He may earn up to four years of service credit for being on military leave; however, he must return as an active member to the fire department within one year of being discharged from the military and subsequently earn a year of service credit to be credited with service credit for the military leave. Anthony Larkin was previously on military leave and returned active in 2014. If he earns 50 points in the future, he will be credited with 4 years of military leave service credit.

Pre-entitlement age participant Stephen Larkin died in 2014 and his beneficiary was paid a lump-sum death benefit.

Jack Baker, Matthew Faeth and Michael Mastrantoni earned 50 points in 2014, but were under age 18 as of 12/31/2014 and, therefore, not eligible to participate. They were not awarded service credit for 2014.

2015 REQUIRED CONTRIBUTION

As reported in last year's Annual Report, the minimum required Trust Fund contribution to be made in 2015 is \$171,276. However, we suggest the Town contribute the full amount budgeted.

2016 REQUIRED CONTRIBUTION

The minimum required contribution due to be paid into the Trust Fund in 2016 is \$172,573.

The contribution due in 2016 increased by \$1,297 from the contribution due in 2015. There was an actuarial investment loss during 2014 - the assumed rate of investment return is 6.00% while the actual return in 2014 was 0.17% - which would have normally caused the contribution to increase. However, this increase was offset by two factors:

- (1) The Town made a \$29,672 excess contribution in 2014.
- (2) A shift in participation, including a decrease in the number of pre-entitlement age active participants from 101 to 96 and entitled participants from 43 to 42.

The Town should be aware that there are more post-entitlement age firefighters who are active and earning service credit. This component of the cost increased by roughly \$4,000, but the factors noted above offset this increase. We expect this trend to continue over the next several years and, therefore, suggest the Town continue to budget and contribute \$207,000 for this program.

INVESTMENT RETURN AND FUNDED RATIO

Calendar year 2014 marks the second consecutive year in which the investment return on the Trust Fund assets failed to meet our long-term assumption of 6.00%. The Town should keep in mind just that — this is a *long-term* return assumption. With that being said, we continue to be concerned about the impact of short-term market volatility on the annual returns and future contributions. Penflex and the RBC staff have had, and will continue to have, many discussions about the long-term outlook of returns based on the Investment Policy adopted by the Town Board. Our transition to the lagged contribution approach will help the Board prepare and budget for contribution increases, but will not prevent them. We suggest reviewing the current investment policy with RBC and contact us with any questions about the long-term costs of the Program.

The program's funded ratio is 90% as of 1/1/2015, a decrease from the 91% ratio from the last two years. The funded status of the program decreased slightly due to the actuarial investment loss, but the excess contribution helped keep it higher than it otherwise would have been. We will continue to monitor the funded ratio for the Town. We suggest the Town contribute the full amount budgeted in 2015 to further strengthen the program's funded status.

2015 REQUIRED CONTRIBUTION

As reported in last year's Annual Report, the minimum required Trust Fund contribution to be made in 2015 is \$83,185. However, we suggest the Town contribute the full amount budgeted.

2016 REQUIRED CONTRIBUTION

The minimum required contribution due to be paid into the Trust Fund in 2016 is \$83,897.

The contribution due in 2016 is relatively unchanged from the contribution due in 2015. There was an actuarial investment loss during 2014 - the assumed rate of investment return is 6.00%, while the actual return in 2014 was 0.17% - which would have normally caused the contribution to increase. However, this increase was offset by three factors:

- (1) The Town made an \$11,481 excess contribution in 2014.
- (2) There were two fewer post-entitlement age firefighters (firefighters who reached age 60 prior to 2014) that earned 50 points in 2014, which lowered that component of the contribution.
- (3) Other changes in the volunteer participation, including a decrease in the number of preentitlement age active participants from 52 to 50.

The Town should be aware that there are two firefighters who will be post-entitlement age in 2015 that we expect to earn 50 points in 2015, and so this savings will be short-lived. Therefore, the Town should continue to budget at least \$95,000 annually.

Patrick Griffin (1/1/2015), Michael Johnson (9/1/2014), and Joshua Rikleman (10/1/2014) reached the entitlement age and were eligible to commence receiving their accrued monthly service awards on the dates indicated. Mr. Rikleman's payments did not begin until 2015, and the payments he was owed in 2014 have been held as a payable from the program assets.

CHANGE IN ACTUARIAL ASSUMPTIONS

We have changed the rate of return assumption used to calculate the 2015 contribution from 6.25% to 6.00%. As stated last year, we feel this change is necessary given the historical return on the program assets as well as the expected future returns. We expect that future contributions will remain near the \$50,000 level; however, we suggest the Town consider increasing future budgets slightly.

2015 REQUIRED CONTRIBUTION

The minimum required Trust Fund contribution to be made in 2015 is \$48,218.

The required contribution due in 2015 is \$4,354 higher than contribution that was due in 2014 of \$43,864. The contribution increase is the result of the change in the interest assumption noted above. The Town made a \$4,000 excess contribution in 2014 which helped offset this increase. The Trust Fund assets earned 6.35% during 2014, which is slightly more than our assumed rate of 6.00% and helped further offset the increase in the contribution.

The program's funded ratio on a program termination basis is 107% as of 12/31/2014 compared to 108% as of 12/31/2013. The funded ratio dipped slightly due to the change in the interest assumption, but the program funded status remains healthy at slightly more than 100%. We will continue to monitor the program's funding progress.

SPECIAL NOTES

Non-vested program participant Jessica Bonavenia left the Corps. during 2014 and consequently forfeited her accrued service award and service credit earned through 12/31/2014. However, if any former participant returns as an active member within five years and subsequently earns a year of service credit, their accrued service award and service credit will be restored.

Vested participants Richard Litsky and Sari Rasas left the Corps. during 2014 and their status has been changed from Active to Terminated Vested.

ENGINEERING REPORT

FORMATION LAKE SECOR PARK DISTRICT CARMEL (T)

INTRODUCTION

The residents of Lake Secor area with deeded rights to utilize Lake Secor are seeking to implement a long term plan for the preservation of the beach facility through a taxation district. This is considered necessary because the Homeowners' Association cannot continue to maintain the beach facility due to the failure on behalf of many area residents to financially support the Homeowners' Association.

Without the creation of a Park District, the beach area would be abandoned.

DESCRIPTION OF FACILITIES

The beach is located on Lakeshore Drive at the Center Street intersection. The beach area is approximately a 145 foot by 45 foot sandy area that is protected by a six foot high chain link fence with a locked gate. Two boat moorings and two metal movable rafts are located in the water

A picnic area, playground set and 9 foot by 12 foot shed are within the beach property.

PROPOSED PARK DISTRICT

The geographic area of the proposed Park District consists of all properties with deeded rights to Lake Secor as shown on the subdivision map of Lake Secor dated December 19, 1930, revised by Supreme Court order May 22, 1931, filed February 27, 1932, prepared by William A. Smith, Civil Engineer, map #151, plate 1 and plate 2.

The proposed Park District area is located generally north of Secor Road, west of Lake Secor and east of the NYSE&G right of way

IMPROVEMENTS

No capital improvements are considered necessary or proposed at this time, including dredging.

COST OF ACQUISITION

The Homeowners' Association is offering the beach property to the Park District at no cost.

C & M COSTS

Operation and maintenance consists mainly of routine landscaping, grass cutting and lifeguarding. Yearly operation and maintenance costs are estimated at \$15,000.00 or approximately \$30.00 per homeowner.
