RESOLUTION FROM 3/4/09 AMENDED REQUIRING CONTRACTORS TO UTILIZE APPRENTICESHIP PROGRAM AMENDED 8/15/18

WHEREAS the New York State Legislature has previously declared it public policy of the State of New York to develop sound apprenticeship training standards and to encourage labor and industry to participate in such programs; and

WHEREAS, §816-b of the New York State Labor Law authorizes local government to require contractors and subcontractors on public construction projects to provide apprenticeship training programs; and

WHEREAS, such apprenticeship programs are a valuable tool to provide training opportunities for young persons skilled in the construction trades and to assist such persons in future professional endeavors; and

WHEREAS, it is deemed to be in the best interests of the Town of Carmel to afford opportunities for training in the appropriate building trades on public construction contracts, as defined in §816-b of the New York State Labor Law, which are bid and awarded by the Town of Carmel and which are greater than or equal to \$1,000,000 (One Million Dollars) in contract price; and

NOW, THEREFORE, BE IT RESOLVED that it is hereby declared to be the policy of the Town of Carmel to require contractors and subcontractors on construction contracts, as defined in §816-b of the New York State Labor Law, which are bid and awarded by the Town of Carmel and which are greater than or equal to \$1,000,000 (One Million Dollars) in contract price, to have in place agreements providing apprenticeship training programs approved by the Commissioner of the New York State Department of Labor for the scope and type of work proposed; and

BE IT FURTHER RESOLVED that said agreements providing the aforementioned apprenticeship training programs be required to conform in all respects to the procedures and requirements set forth in §816-b of the New York State Labor Law.

PUBLIC COMMENTS - AGENDA ITEMS

Michael Barile expressed his resounding support for the awarding of a long-term contract to Bee & Jay Water Systems Plumbing & Mechanical.

Mr. Barile questioned the amendment to the policy of the Town of Carmel to require contractors and subcontractors on construction contracts to have agreements in place providing apprenticeship training programs.

Supervisor Schmitt explained that the threshold for the policy participation has been increased from \$100,000.00 to \$1 million.

TOWN BOARD MEMBER COMMENTS - AGENDA ITEMS

No member of the Town Board wished to comment at this time.

PUBLIC COMMENTS - OPEN FORUM

Mr. Barile inquired about the protocol for a resident to request a matter be included on a Town Board meeting agenda.

Councilman Lupinacci indicated that in addition to the Supervisor, the matter can be brought forth to any member of the Town Board.

Mr. Barile inquired if a Town of Carmel employee is responsible for the maintenance of the Town Hall building or if it is contracted out.

Supervisor Schmitt replied that one full-time and one part-time employee maintains the Town Hall.

Mr. Barile noted his dissatisfaction with the appearance of the building.

Jose Ojeda expressed his frustration with the deplorable condition of his neighboring properties at 305 Rockledge Road, 315 Rockledge Road and 66 Orchard Road in Lake Secor. Mr. Ojeda stated that the properties are subjects of foreclosure proceedings. In addition to negatively impacting property values in the area, he stated that they are a safety hazard to both children and adults. Mr. Ojeda spoke regarding his past communications with the Town to have the situation improved.

At the conclusion of discussion held with regard to the matter, Supervisor Schmitt assured Mr. Ojeda that he would address his complaint with Michael Carnazza, Director of Code Enforcement/Building Inspector in an effort to remedy the issue.

TOWN BOARD MEMBER COMMENTS - OPEN FORUM

Councilman Schneider announced that the Carmel Fire Department will be hosting their 100th Anniversary Parade on August 22, 2015. Activities commence at 2:00 p.m. and the celebration will conclude with a fireworks display at 9:00 p.m.

Supervisor Schmitt announced that the Italian American Club of Mahopac is sponsoring their annual Evening in the Piazza on August 22, 2015 at the Mahopac Chamber Park from 5:00 p.m. to 10:00 p.m.

Supervisor Schmitt reminded residents that the hours of operation for the recycling container for the disposal of electronic waste located at 48 McAlpin Avenue are from 10:00 a.m. to 2:00 p.m. on Saturdays. Residents should not drop off items after hours or they may be charged with littering. A complete list of acceptable and non-acceptable electronics is available on the Town of Carmel's website at www.carmelny.org.

Councilman Lombardi encouraged residents to utilize the secure drop-off box located in the Carmel Police Department for the disposal of unused prescription drugs.

Supervisor Schmitt spoke regarding the importance of the proper disposal of unused prescription medications.
