AGREEMENT

V CC. FRINCIPA

THIS AGREEMENT, made this 1st day of November, 2009, by and between the TOWN OF CARMEL, with offices at Town Hall, 60 McAlpin Avenue, Mahopac, New York 10541 (hereinafter referred to as the "TOWN"), and JOHN KARELL, Jr., P.E., whose address is Cushman Road, Patterson, NY (hereinafter referred to as "KARELL").

WITNESSETH:

WHEREAS, the TOWN desires to secure the services of an licensed professional engineer to provide consulting engineering services to the TOWN; and;

WHEREAS, KARELL is an experienced engineer properly licensed by the State of New York and is willing to be retained as consulting engineer for the TOWN;

NOW THEREFORE IT IS AGREED:

SECTION I - EMPLOYMENT

KARELL is hereby retained to provide consulting engineering services to the Town in form, scope and detail as outlined in the proposal for engineering services attached hereto as Exhibit "A".

SECTION II - COMPENSATION

For basic services to be performed hereunder, TOWN agrees to pay KARELL a fixed weekly fee of One Thousand Three Hundred no/hundredths (\$1,300.00) dollars payable in advance on the first of each month. TOWN shall have the right to increase compensation due under this contract by resolution of the Town Board duly passed without a written amendment to this contract.

SECTION III - EXPENSES

It is understood and agreed that any reasonable expenses incurred by KARELL in connection with the duties contemplated in this agreement will either be paid directly by the TOWN or if advanced by KARELL will be reimbursed by the TOWN upon review and audit of vouchers submitted by KARELL for such reimbursement.

SECTION IV - INDEMNIFICATION

TOWN agrees to indemnify KARELL and hold KARELL harmless from any and all judgments, losses, costs and expenses and the like, including attorney's fees incurred by reasons of the action or omission of KARELL or his agents, servants or employees, in connection with KARELL's provision of services under this agreement except for intentional negligence. Nonetheless, KARELL agrees to maintain professional malpractice insurance at all times during this agreement in a minimum amount of One Million and no/hundredths (\$1,000,000.00) dollars.

SECTION V- TERM

The terms of this agreement shall commence on November 1, 2009 and may be terminated by resolution of the Town Board upon no less than thirty (30) days written notice to KARELL.

SECTION VI- RENEWAL

This contract shall be subject to renewal and/or extension by mutual written agreement of the parties.

SECTION VII- KARELL NOT AN EMPLOYEE

It is further understood and agreed by the TOWN that KARELL shall serve in the capacity of an independent contractor. KARELL agrees not to hold himself out as an officer or employee of the TOWN nor shall he make any claim against the TOWN as an officer or employee thereof for such benefits as Workers Compensation coverage, Unemployment Insurance benefits, Social Security coverage or Retirement Membership or Credit or any other benefits accruing to said officers or employees of the TOWN. Nothing contained herein shall be deemed to prohibit the TOWN from providing said benefits if it is legally permissible and if the TOWN elects to do so.

(Cont.)

Supervisor Schmitt stated that the former Town Engineer's services are being retained temporarily on a consulting basis until the Town Board appoints a new Town Engineer.

PUBLIC COMMENTS

Marc Pekowsky offered his congratulations to the newly elected Town Council members.

Fred Lambert suggested that in an effort to save money, the Town officials and employees attending the Association of Towns Conference forgo overnight stays at hotels in New York City.

Supervisor Schmitt explained that the seminars commence early in the morning and conclude late in the evening.

Mr. Lambert suggested that the officials and employees stagger their attendance at the conference and report back to each other.

Supervisor Schmitt stated that the attendees have the option of commuting. In the past, however, the Town has always authorized overnight accommodations for this conference.

Mr. Lambert questioned the status of Councilwoman McDonough's employment at the Town of Carmel Department of Recreation and Parks.

Councilwoman McDonough indicated that she had resigned from her position as of the end of December.

David Gagliardi also expressed congratulations to the new members of the Town Board. Mr. Gagliardi inquired about the costs associated with various resolutions, noting that certain resolutions read at the meeting contained the monies involved, while others did not. He commented that he did not oppose the attendance of employees at the conference, but feels the monies spent should be included in the Town record.

Supervisor Schmitt stated that when the expense vouchers are submitted for the conference, he would make it a point to provide the information to the public at a future meeting. Supervisor Schmitt then called upon Mr. Folchetti to assist him in responding to Mr. Gagliardi's inquiry regarding the costs associated with various resolutions.

Mr. Folchetti indicated that the compensation for Town Counsel is \$90,000.00 per year and \$35,000.00 per year for Districts Counsel. Miscellaneous legal services are typically billed by the hour at \$125.00 per hour for board work and \$175.00 per hour for litigation related work.

Supervisor Schmitt stated that the Deputy Comptroller's annual salary for 2010 is \$67,400.00. The position of Confidential Secretary to the Supervisor is combined with Assistant to the Town Board at an annual salary of \$64,000.00.

Mr. Gagliardi inquired about the Resolution Designating Official Depositories.

Councilman Ravallo stated that the Town Board designated any commercial bank authorized to do business in New York State.

Mr. Gagliaridi recognized that naming "any" bank allows for flexibility and will permit the Town to obtain the maximum rate of interest. Mr. Gagliaridi reiterated that he was not objecting to monies being spent by the Town, but feels the amount should be included in the public record.

6 JANUARY 2010 ORGANIZATIONAL MEETING

TOWN BOARD MEMBER COMMENTS

Supervisor Schmitt invited the public to join him, along with Thomas Manko, Mahopac Central School District Superintendent on Thursday, January 21, 2010 from 7:00 p.m. to 8:30 p.m. at the Lakeview Elementary School auditorium for "The Hope Forum", a roundtable discussion to raise awareness and find solutions to the recent trend of serious vehicle accidents, as well as, alcohol related tragedies that have involved the youth in the community over the past few years. Discussion ensued regarding the initiative, in addition to issues relating to it.

Supervisor Schmitt announced that the Town of Carmel is seeking interested persons to fill vacancies on the Planning Board, the Zoning Board of Appeals, the Architectural Review Board, and the Environmental Conservation Board. Applicants should submit a letter of interest and resume to the Town Supervisor's office by January 15, 2010.

Councilman Lombardi reflected on whether or not there remains a need for certain boards in addition to whether or not the terms of office for certain boards for should be modified. He recommended that the Town Board review the issue.

Supervisor Schmitt stated that he would include the matter on an upcoming Work Session agenda.

PUBLIC COMMENTS CONTINUED

Marc Pekowsky expressed support of Councilman Lombardi's aforesaid recommendation and suggested that the Town Board look into rescheduling the various board meetings so that the times and days do not conflict with one another.

TOWN BOARD MEMBER COMMENTS

Councilman DiCarlo stated that the next meeting of the Zoning Compliance Committee meeting will be held on Tuesday, January 26, 2010. He further stated that at the next Work Session, upon the suggestion of the Committee, there will be a discussion held regarding the pros and cons of a town-wide garbage district.

Councilman Lombardi addressed the need for certain businesses along the Route 6 corridor to improve their appearance. He held a brief discussion with Councilman DiCarlo regarding the matter.

Supervisor Schmitt announced that the next meeting of the Town Board will be a Work Session held on January 13, 2010 at 7:00 p.m.

ADJOURNMENT

All agenda items having been addressed, on motion by Councilman DiCarlo, seconded by Councilman Ravallo, with all members present and in agreement, the meeting was adjourned at 8:10 p.m. to Executive Session with Mary Ann Maxwell, Deputy Comptroller and Eileen Brennan, Principal Account Clerk, to discuss reporting regulations for the New York State Retirement System for elected and appointed officials.
