A Special Meeting of the Town Board of the Town of Carmel was called to order by Supervisor Kenneth Schmitt on the 9th day of June 2010 at 7:11 p.m. at Town Hall, 60 McAlpin Avenue, Mahopac, New York. Members of the Town Board present by roll call were: Councilman Ravallo, Councilman Lombardi, Councilwoman McDonough, Councilman DiCarlo, and Supervisor Schmitt.

The Pledge of Allegiance to the Flag was observed prior to the start of official business and a moment of silence was observed to honor those serving in the United States Armed Forces.

order to allow the Town Board time to complete its review, draft proposed new regulations and enact any new regulations regarding outdoor wood boilers, the Town Board deems it in the best interest of the general health, safety and welfare of the residents of the Town of Carmel to impose a moratorium on the issuance of any new permits for the installation, enlargement or extension of outdoor wood boilers on a temporary basis. Section 3: MORATORIUM Section 59-49 of the Town Code of the Town of Carmel is hereby amended by the addition of a new subparagraph D. which shall read as follows: D. Councilman DiCarlo explained that the Town is continuing with the process of reviewing other legislation from around the State and drafting new regulations regarding outdoor wood boilers. The crux of the issue is the size of the outdoor wood boilers' stack and ensuring that the smoke blows up and out, away from the neighbors.

Supervisor Schmitt noted that the moratorium is being extended to allow the Building Inspector, Michael Carnazza, time to further conduct research regarding the matter.

Councilman Ravallo added that the moratorium applies to new units and commented on possible requirements for the installation of new units.

CARMEL WATER DISTRICT #8 - EMERGENCY DECLARED AND EXPENDITURE OF MONIES FROM THE REPAIR RESERVE FUND - AUTHORIZED

WHEREAS, the Town Board of the Town of Carmel has been advised by its Engineering Consultant John Karell, Jr., P.E. that there exist emergency conditions and circumstances which concern and may effect the quality of the public water supply in Carmel Water District #8 at the present time; and

WHEREAS, the Town of Carmel maintains a Repair Reserve Fund for Carmel Water District #8, duly established pursuant to General Municipal Law §6-d; and

WHEREAS, in cases of emergency, monies in such Repair Reserve Fund may be expended pursuant to resolution approved by not less than two-thirds of the members of the governing body; and

WHEREAS, it is recommended by the Office of the Town Comptroller that monies in the Repair Reserve Fund be used to pay for the cost of emergency repairs to the water supply and distribution lines within Carmel Water District #8;

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Carmel, acting as Commissioners of Carmel Water District #8, hereby determines and declares that an emergency situation presently exists with respect to the public water supply within Carmel Water District #8; and

BE IT FURTHER RESOLVED that the Town Board of the Town of Carmel, acting as Commissioners of Carmel Water District #8, hereby authorizes the appropriation of monies from the Carmel Water District #8 in a total amount to be determined and established by future resolution of the Town Board;

BE IT FURTHER RESOLVED that not less than one-half of the monies so expended be repaid in fiscal year 2011 and that the total amount of the monies so expended be repaid in full not later than the last day of fiscal year 2012.

Supervisor Schmitt explained the emergency conditions regarding the quality of the water supply in Carmel Water District #8 in that the residents on Country Road are experiencing brown water coming out of their faucets.

Robert Vara, Town Engineering Project Coordinator, detailed his investigation with regard to the problem and outlined the Town's options for remediation. Mr. Vara then went on to address questions posed by the members of the Town Board at the conclusion of which, Supervisor Schmitt called for a roll call vote.

Prior to voting, Councilman Ravallo expressed his concern regarding the last paragraph included in the aforementioned resolution and the potential cost of the repairs.

Greg Folchetti, Town Counsel noted that the purpose for the resolution is to declare that an emergency situation presently exists in Carmel Sewer District #8 with the monies to be expended to be determined and established by future resolution of the Town Board.

Mary Ann Maxwell, Deputy Comptroller pointed out that if the cost of the repairs exceeds the funds in the Repair Reserve Fund, the Town will be required to borrow monies.

Discussion continued regarding the matter, at the conclusion of which, Supervisor Schmitt resumed the aforesaid roll call vote.

PUBLIC COMMENTS

Lance Marino, a resident of Country Lane addressed the issue of his poor water quality, noting that it has worsened over that past several months. Mr. Marino commented on possible solutions.

Supervisor Schmitt assured the residents of Carmel Water District #8 that the Town will continue to investigate the problem, maintain communication with regard to the problem and remedy it.
