MOTION TO ABOLISH THE FULL-TIME POSITION OF CARMEL TOWN ENGINEER - NO SECOND - FAILED

Councilman Barile offered a motion to abolish the full-time position of Carmel Town Engineer. The motion did not receive a second.

Councilman Barile asked if any of his colleagues on the Town Board knew why the Town of Carmel is the only town in Westchester County or Putnam County that has both a full-time Town Engineer and an engineering consultant as well as why the Town of Carmel has the highest budgeted engineering department.

Supervisor Schmitt indicated that he did not exactly know why.

Councilman Schneider recommended that the matter be addressed at a future Work Session and discussion was held regarding the matter.

PUBLIC COMMENTS - AGENDA ITEMS

Dave Nichols referenced the resolution accepting the proposal of the Pinsky Law Group, PLLC and confirmed that it was for a one year contract. He then questioned whether or not there was anyone on the Town's payroll that could review the fire department and ambulance contracts to save the taxpayers \$20,000.

Councilman Lupinacci stated that as a result of the situation with the Mahopac Volunteer Fire Department, for the protection of the taxpayers the Town Board sought to retain an independent third party expert to provide control and safe gaps in connection with their financials.

Mr. Nichols asked why Mr. Folchetti reviews the contract for the Mahopac Falls Volunteer Fire Department.

Mr. Folchetti explained that Mr. Pinsky has taken over the part of the contract negotiations for the annual agreements with the Mahopac Volunteer Fire Department, Carmel Fire Department and the Carmel Volunteers Ambulance Corps but the overwhelming majority of his services are related to the auditing of the day-to-day finances of the Mahopac Volunteer Fire Department so that in light of the events in 2015 and 2016, the Town Board is convinced that their contract payments are being appropriately used.

Mr. Nichols inquired if any of the funds that were misappropriated from the Mahopac Volunteer Fire Department had been recovered.

Supervisor Schmitt stated that \$1 million was paid to the fire department from an insurance claim.

Mr. Folchetti added that restitution was part of the plea agreement.

Mr. Nichols asked if the Mahopac Volunteer Fire Department was granted the contract increase that they requested for 2018.

Supervisor Schmitt stated that it was not.

TOWN BOARD MEMBER COMMENTS - AGENDA ITEMS

No member of the Town Board wished to comment at this time.

PUBLIC COMMENTS - OPEN FORUM

Don Fitzpatrick inquired about the status of the \$2.3 million water main replacement project in Carmel Water District #2.

(Cont.)

Mr. Folchetti explained that at the next Work Session, the actual plan for the implementation of the improvements will be included on the agenda and that the earliest that the contract could be voted on to award for the work would be February 7, 2018 based on the estoppel period. He further explained that some of the other concerns regarding the facilities within the district will also be on the agenda. Discussion ensued with regard to the water issues in Carmel Water District #2.

TOWN BOARD MEMBER COMMENTS - OPEN FORUM

Councilwoman McDonough announced that the Town Board will be discussing possible legislation to regulate lake dock bubblers and deicing systems at their next Work Session.

Supervisor Schmitt added that the Town Board will also be addressing a proposed agreement with regard to towing, the Town parks and proposed revisions to the Town wetland regulations.

Supervisor Schmitt announced that the Greater Mahopac-Carmel Chamber of Commerce will be hosting a Spring Fair on April 28, 2018 from 1:00 p.m. to 5:00 p.m. in the hamlet of Carmel. There will be vendors, food, entertainment and rides.

ADJOURNMENT

All agenda items having been addressed, on motion by Councilwoman McDonough, seconded by Councilman Lupinacci, with all Town Board members present and in agreement, the meeting was adjourned at 7:49 p.m. to Executive Session to discuss a matter of personnel in connection with the Town of Carmel Court.
