Reassemble the Safety Committee as per the recommendation outlined in PERMA's letter to the Town of 10/9/12. PERMA will have representation quarterly at the Safety Committee meetings and assist with the design of an effectively run, well organized meeting. This will include review of accident investigation reports and large losses to develop practical solutions to prevent reoccurrences. First meeting of the newly reassembled committee must occur within 90 days of the inception date and quarterly thereafter.

Housekeeping at the Town Highway Garage must be improved. Conditions of the garage and equipment were noted to be poor. This involves very little cost and needs to be completed <u>within 60 days</u> of the inception date.

Commit to negotiating with the union to implement the transitional duty program into the next contract, including the DPW Department.

Employees must receive updated training annually in proper lifting techniques, back injury protection and slip/fall prevention to reduce the frequency and severity of overexertion and slip/fall claims. PERMA will provide initial training at 3, 6 and 9 months into the coverage period.

Dear Mr. Schmitt, Town Supervisor:

Testimony was presented by Mr. Lansky and Mr. Daniel D. Tartaglia,Esq. (Attorney for Mr. Paul E. Jonke)on December 4, 2012 and further testimony was presented by both parties on January 8, 2013.

At the conclusion of the January 8<sup>th</sup> meeting the BOE discussed Complaint 2012-01. The BOE voted unanimously that Mr. Paul E. Jonke was in violation of Ethics Code of the TOC Section 22-3 Para. H: "..... The provisions herein shall be limited to a period of two years for any officer or employee after termination of employment. No officer or employee of the Town shall, after the termination of service or employment with the Town appear before any board or agency of The Town in relation to any case proceeding or application in which he personally participated during the period of his service or employment or which was under his active consideration."

**BOE Recommendations:** 

- 1. Dealings of Mr. Jonke with tax adjudication in the TOC should cease immediately upon the Town Board's decision that there was a violation of Section 22-3 Para. H.
- 2. The 2 year hiatus period referred to in Section 22-3 Para. H in the Code of Ethics should commence upon TOC's decision and end 2 years after this decision.

Supervisor Schmitt explained that the Police Department is switching their fleet over from Ford because the Crown Victoria is no longer being manufactured. The police department administration and mechanic researched the different types of vehicles and decided on Chevrolets. He stated that \$43,000 was budgeted and the remaining monies will be taken out of the seized assets fund. The Town mechanic will be retrofitting the vehicles at no cost.

Councilman Lupinacci added that the fleet's colors are being changed from white and blue to silver and blue.

# **OPEN FORUM - PUBLIC COMMENTS**

Russ Braun inquired about the cost to Town of Carmel residents for funding the Putnam County Sherriff's Department. He suggested that a significant financial savings could be achieved through local law enforcement services consolidation.

Supervisor Schmitt explained that a portion of taxpayers' dollars go towards funding the department which is mandated to provide a jail and civil bureau. A brief discussion ensued.

Mr. Braun inquired about who funded the new sidewalks recently installed in the hamlet of Carmel.

Supervisor Schmitt stated that the funding for the sidewalks came from a New York State Department of Transportation program.

Mr. Braun asked who is responsible to pay for the cleaning of the commuter parking lot located at the corner of Route 6 and Mt. Hope Road.

Supervisor Schmitt stated that the parking lot is maintained by the Putnam County Department of Highways and Facilities and paid for through county property taxes.

# OPEN FORUM - TOWN BOARD MEMBER COMMENTS

Councilman Lupinacci inquired about whether or not the Putnam County Sherriff's Department coordinates their patrol assignments with the Town of Carmel Police Department.

Supervisor Schmitt stated that he did not believe that they did. A vehicle is assigned by the county to a sector that includes the Town of Carmel and another town. He pointed out that the Sherriff's Department will respond if contacted by a resident and will provide backup to the Carmel Police Department when needed.

Councilman Lupinacci announced that the second annual Cupcake Wars will be held on February 23, 2013 from 11:00 a.m. to 2:00 p.m. at the Mahopac High School. Proceeds from the event with benefit the Mahopac Educational Foundation.

Councilman Lombardi announced that an emergency bone marrow drive is being held on March 3, 2013 from 11:00 a.m. to 3:00 p.m. at the Knights of Columbus Hall in Carmel for former Carmel resident Denise Cordovano-Kula who was diagnosed with leukemia.

Councilman Schneider added that an individual must be between the ages of 18 and 55 to be eligible.
