

TOWN BOARD MEMBER COMMENTS - AGENDA ITEMS

Councilman Lombardi announced that at his request, the Town Board meeting agendas may now be accessed on the Town of Carmel website as a separate file from the supporting documentation to allow for greater ease of downloading.

OPEN FORUM

Michael Barile addressed the report presented at the prior Work Session by Michael Carnazza, Director of Codes Enforcement/Building Inspector, concerning Compliance Cleanup Week. He suggested that rather than Town of Carmel personnel attempting to remove illegal signs themselves, the businesses who erected the signs should be contacted to remove them. If they do not comply, fines should be instituted. Mr. Barile went on to inquire when reports will be provided with regard to the state of the Recreation Commission and the Police Department.

Councilman Lombardi stated that a Recreation Department update was provided at the last meeting and that the Police Department report is forthcoming. A brief discussion was held.

Jerry Ravnitzky referenced the recent house fire in Carmel which resulted in the tragic loss of four members of the Sullivan family. He stated that reports in the media indicated that the materials used in building the house contributed to the flames engulfing the house in a short period of time. Mr. Ravnitzky suggested that the Town Board enact a law to prevent this from happening again.

Supervisor Schmitt stated that the investigation into the matter is ongoing. He pointed out that the house was built to New York State Code in 1999.

TOWN BOARD MEMBER COMMENTS

Councilman Lombardi congratulated the newest Town of Carmel Eagle Scout, Mahopac resident Richard Hoover for his outstanding accomplishment.

Supervisor Schmitt and Councilwoman McDonough spoke regarding the recent fishing derby held at Lower Teakettle Lake. They commended the members of the Teakettle Spout Lake Park District Advisory Committee for their outstanding efforts.

Supervisor Schmitt read a letter of appreciation from Anne McAndrews, the mayor of Larchmont for the assistance that the Town of Carmel provided during the funeral services of Captain Thomas Sullivan of the Larchmont Police Department, his wife and daughters.

Supervisor Schmitt announced that the Putnam Arts Council will be presenting Art After Seventy-Five, a celebration of fine art created by artists seventy-five years old and over, at the Belle Levine Art Center from May 20, 2012 through June 15, 2012.

Supervisor Schmitt announced that the Concerned Residents of Carmel and Mahopac will be hosting a pre-primary candidates' forum on June 5, 2012 at 7:00 p.m. at the Mahopac Library.
