TOWN BOARD MEETING TOWN HALL, MAHOPAC, N.Y.

A Regular Meeting of the Town Board of the Town of Carmel was called to order by Supervisor Kenneth Schmitt on the 20th day of July 2011 at 7:17 p.m. at Town Hall, 60 McAlpin Avenue, Mahopac, New York. Members of the Town Board present by roll call were: Councilman Ravallo, Councilman Lombardi and Supervisor Schmitt. Councilwoman McDonough was absent.

The Pledge of Allegiance to the Flag was observed prior to the start of official business and a moment of silence was observed to honor those serving in the United States Armed Forces.

PUBLIC HEARING CONTINUED FROM 6/22/11 - THE ESTABLISHMENT OF RATES FOR RESIDENTIAL GARBAGE AND REFUSE PICKUP FOR YEAR 2011

At 7:17 p.m. Supervisor Schmitt reopened the Public Hearing that was commenced on June 22, 2011 with regard to the establishment of rates for residential garbage and refuse pickup for the year 2011. Twenty-one (21) people were in attendance.

Norman Marino inquired if all carters would be subject to the new rates.

Supervisor Schmitt stated that they would be when the rates are established for 2011. The current rate is \$25.00 per month for once-a-week pickup. The law was recently amended to include twice-a-week pickup.

Mr. Marino inquired if the new rate will be \$25.00 per month.

Supervisor Schmitt stated that the rate is yet to be determined.

Mr. Marino inquired if the garbage carting companies were providing input with regard to setting the rates.

Supervisor Schmitt stated that input is being sought from carters and residents.

Mr. Marino inquired why some carters are still charging over \$25.00 for monthly garbage pickup.

Gregory Folchetti, Town Counsel, explained that the only rate in effect at this time is \$25.00 per month for once-a-week pickup. The law was amended a month ago to establish that a rate will be set for once-a-week pickup, up to a maximum of 96 gallons of refuse and twice-a-week pickup, up to a maximum of 192 gallons of refuse. When the Public Hearing is closed and the Town Board processes the information from the Public Hearing along with the submissions from the carters and private individuals, they will set ceiling rates for 2011 for once-a-week pickup and twice-a-week pickup. The carters may choose to set their rates at or below this rate.

Mr. Folchetti noted that it was his belief that every application that has been approved since the Town Board established the \$25.00 monthly rate in December has been at that rate or lower. The carters charge what they believe they need to charge for twice-a-week pickup because there is no established rate for that at this time.

Mr. Marino asked if there were previously approved carter licenses applications not at the \$25.00 monthly rate.

Mr. Folchetti indicated that there were.

Mr. Marino asked if the public will be given the opportunity to further comment on the rates before they are set.

Supervisor Schmitt stated that it was the intent of the Town Board to close the Public Hearing tonight and to set the rates at a subsequent meeting.

Councilman Ravallo pointed out that a lengthy discussion was held when this Public Hearing commenced at a prior meeting. Input from the public with regard to the rates, as well as any other matter was received.

Supervisor Schmitt explained that this was the time for the public to provide their input with regard to the rates. There will not be any further opportunity to comment with regard to what the rates will be.

Mr. Marino stated that he did not want to propose a rate. However, he would like to know what the Town Board's proposed rates are before he would comment on them. He said that if the rate returns to \$40.00, nothing has been accomplished.

Councilman Ravallo noted that prior to voting on a resolution, the matter is discussed at a Work Session. The public will have the opportunity to comment on the matter at the end of that Work Session.

Mr. Marino inquired if the Town Board has come to a determination with regard to setting the rates at this time.

Supervisor Schmitt replied, no.

David Gagliardi referenced a comment made at an earlier meeting and asked if there are eight carters operating in the Town.

Supervisor Schmitt replied, yes.

Mr. Gagliardi confirmed that there would not be an issue with a ninth or tenth carter doing business in the Town of Carmel.

Supervisor Schmitt indicated that there would not be as long as they meet the licensing criteria established by the Town.

Councilman Ravallo stated that they want to welcome competition, not curtail it.

Michael Barile stated that a couple of years ago, when the issue of town-wide garbage collection fell upon the Route 6 Compliance Committee, they conducted research. They concluded that since the Town of Carmel had established garbage districts, it would be worthwhile to find out what it would cost taxpayers if town-wide garbage collection was implemented. Mr. Barile stated that the Town Board chose to stop the fact finding process without an explanation and he expressed his frustration for them doing so.

James Constantino, General Counsel for Royal Carting asked the Town Board to consider that the rate being set is a maximum rate, not *the* rate. He asked the Town Board to consider that not all carters have the same cost structure. For example, a company's labor costs are impacted by whether or not they are a union shop. Some companies have buying power, others do not. Some companies are operated by an individual and do not require workers' compensation insurance.

Mr. Constantino stated with regard to town-wide garbage collection districts, that the Town of Yorktown's recent unofficial bid result for twice-a-week pickup is \$23.95 per month. However, this rate does not include disposal. The Town of Yorktown will pay the disposal costs directly to the Westchester County RESCO IMA. He added that there is no bulk service included. Mr. Costantino stated that there has been protracted litigation over the Town of Southeast's low bid at \$23.95 which does not include disposal or bulk service.

Councilman Ravallo asked if disposal costs and tipping fees are the same thing.

Mr. Constantino stated that they were and unlike Yorktown which has a contracted disposal site, Putnam County has no relationships or contracts for the disposal of garbage.

Mr. Constantino asked the Town Board not to penalize a company and not allow them to do business in the Town of Carmel because for whatever reason, their cost structure is different than the company who can operate at the lowest cost level. He stated that there are companies, Royal Carting being one of them, that \$25.00 per month for twice-a-week and bulk pickup would not cover their costs. He concluded that each business should be allowed to determine their own rates for the services that they choose to provide.

Beverly Wallace spoke in favor of town-wide garbage collection and inquired why the Town Board is not pursuing it.

Councilman Ravallo stated that implementing town-wide garbage districts will eliminate competition and that competition is what drove the garbage rates to the current low level. He stated that the rates for town-wide garbage collection will not be lower than the rate of \$25.00 per month presently being charged by certain carters. Councilman Ravallo spoke regarding the disadvantages associated with losing competition.

Ms. Wallace stated that she would like to pay the same rates paid by residents in the towns of Southeast and Patterson.

Councilman Ravallo pointed out that there are additional costs to a municipality associated with town-wide garbage collection.

Supervisor Schmitt stated that there was extensive dialog held and good viewpoints expressed by both sides. However, it was the decision of the Town Board not to move forward with town-wide garbage collection. The rates will be set annually. He indicated that this did not preclude the Town Board from revisiting the matter at a future date.

Jerry Ravnitzky speaking as a member of the Zoning Compliance Committee spoke in favor of town-wide garbage collection. He commented that competition would be occurring when the Town solicits bids from carters for three garbage districts.

Mr. Folchetti clarified that the garbage district that was formed in 1985 is a town-wide district. The bid structure that was considered was three separate sectors within the district.

Councilman Ravallo spoke to the effectiveness of the Town's current system for garbage collection. He noted that if town-wide garbage collection was implemented, it would be an added expense for residents who currently do not pay for garbage collection because they partner with a neighbor for services or dispose of their garbage in some other way.

Judy Ravnitzky pointed out the presence of a stenographer at the meeting and inquired who was paying for her services.

Supervisor Schmitt stated that the stenographer is not being paid by the Town of Carmel.

Ms. Ravnitzky speculated that the services of the stenographer were being paid for by a carter.

Jonathon Schneider inquired about a committee being formed to assist the Town Board with establishing the rates for 2011. He also inquired if the Town Board received financial information from any of the carters and if so, how many.

Mr. Folchetti stated that establishing a committee to gather information with regard to the rates was a suggestion that he had made to the Town Board which they decided not to move forward with. Mr. Folchetti stated that the statute allows for the Town Board to review financials. However, he was unsure if any had been received.

Councilman Ravallo stated that the Town Board has the right to audit the carters and has done so in the past.

Supervisor Schmitt added that when the concept of a committee was brought up, certain members of the public spoke out against it.

Councilman Lombardi pointed out that the Public Hearing with regard to the rates was extended to tonight to allow for the carters to present whatever documentation they chose to. He indicated that two submissions were received.

Mr. Marino commented to the Town Board that they work for the citizens not the carters and that he was not in favor of town-wide garbage collection. Mr. Marino stated that the carters must include their financial information in their license application.

Mr. Folchetti stated that there are questions regarding any bankruptcy proceedings on the license application.

Mr. Marino stated that the rates for garbage collection should either be lowered or remain the same. He expressed his frustration with high taxes.

With no one else present wishing to be heard on the subject of the Public Hearing, on motion by Councilman Lombardi, seconded by Councilman Ravallo, with all members present in agreement the Public Hearing was closed at 7:59 p.m.

CARMEL WATER DISTRICT #4 - EMERGENCY EXPENDITURE OF MONIES FROM THE REPAIR RESERVE FUND AUTHORIZED - NOT TO EXCEED \$12,393

WHEREAS, the Town of Carmel has established a Repair Reserve Fund for Carmel Water District #4 pursuant to New York General Municipal law §6-d; and

WHEREAS, in cases of emergency, monies in said Repair Reserve fund may be expended by resolution approved by not less than two-thirds of the members of the governing body; and

WHEREAS, it is recommended by the Office of the Town Comptroller that monies in the aforesaid Repair Reserve Fund be used to pay for the cost of emergency repairs;

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Carmel, acting as commissioners of Carmel Water District #4, hereby authorizes the appropriation of monies from the Carmel Water District #4 Repair Reserve Fund in a sum not to exceed \$12,393 for emergency repair expenditures in 2011; and

BE IT FURTHER RESOLVED, that not less than one-half the monies so expended be repaid in fiscal year 2012 and the total amount shall be repaid in full not later than the last day of fiscal year 2013.

Prior to the roll call vote, Mr. Folchetti clarified that this resolution requires adoption by two-thirds of the membership of the Town Board.

Supervisor Schmitt stated that the current cable franchise agreement between the Town of Carmel and Comcast Cable expires at the end of the year. Negotiations will begin shortly.

PUBLIC COMMENTS

David Gagliardi asked for the total dollar amount for Town and Special Districts for the Margaret Holdings and Stoneleigh Woods at Carmel, LLC. litigation settlements.

TOWN BOARD MEMBER COMMENTS

Councilman Lombardi announced the details of the upcoming 2011 Town of Carmel Sunset Concert Series to be held at the Mahopac Chamber Park.

Supervisor Schmitt announced the details of the 40th Annual Putnam County 4-H Fair sponsored by the Cornell Cooperative Extension which will be held from July 29th through the 31st at the Putnam County Veterans Memorial Park.

Councilman Lombardi commented that it has been through the efforts of the Town Board that garbage collection rates have been reduced. He expressed his concern that implementing town-wide garbage collection may have resulted in higher taxes. He added that it would be another mandatory tax for residents who chose not to contract for garbage collection services. Councilman Lombardi also expressed his concern that if the number of carters were reduced as a result of the implementation of town-wide garbage collection, individuals may lose their jobs.

Councilman Lombardi commended the Carmel Police Department's Special Conditions Unit for their progress in working to bring to an end the problem of prescription drug abuse among the youth in the community.

Councilman Ravallo commented that this Town Board and many before them have deliberated implementing town-wide garbage collection and concluded that it will cost the taxpayers more money.
