#### MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is entered into by and between the negotiating teams for the Town of Carmel (hereinafter "Employer") and the Town of Carmel Police Benevolent Association ("hereinafter "PBA"). The Employer and PBA are collectively referred to as the "Parties".

WHEREAS, the Employer and PBA are parties to a Collective Bargaining Agreement which expires on December 31, 2021; and

WHEREAS, the parties have now reached an agreement as of the date of execution of this Memorandum of Agreement on the terms and conditions for a successor collective bargaining agreement for the period of January 1, 2022 to December 31, 2029, and wish to memorialize their understanding, in writing, pending the signing of the new collective bargaining agreement; and

**NOW, THEREFORE,** in consideration of the promises and mutual covenants contained herein, upon ratification by the PBA and approval by the Town Board by resolution, which the Parties' representatives to this Memorandum of Agreement shall support and recommend ratification before their respective bodies, the Parties agree that a successor collective bargaining agreement to the expired agreement shall reflect the following changes; all other terms and conditions not specifically referenced herein shall, by agreement of the parties, remain in full force and effect.

### Add NEW Section D:

The Department shall specify the days on which the thirteen (13) designated holidays will be observed before the start of the calendar year.

### 3. Article VIII — DEATH LEAVE

Add grandparents, step-parents, and step-siblings to list for death leave eligibility.

### 4. Article XVI - LONGEVITY Replace the Article with the following:

All employees hired on or before January 1, 2016 shall receive longevity payments based on years of continuous service with the Town as a Police Officer as follows:

#### 5. Article IV - ANNUAL SALARY AND OVERTIME

Amend Section 3 by changing the maximum accumulation of compensatory time hours (time owed) from thirty-two (32) to one hundred sixty (160).

### 6. Add a NEW Article as follows: PARENTAL LEAVE

The Town will provide 5 days of paid parental leave to employees following the birth or placement for adoption of a member's child.

### 7. Add a NEW Article as follows: DETECTIVE ON CALL

In the event there are 3 or fewer members at the rank of detective in the detective division, any detective required to be on call more than 10 days in a calendar month shall be credited with one hour of compensatory time for each extra on call shift (i.e., each shift beyond 10 for the month).

In the event there are 4 or more members at the rank of detective in the detective division, any detective are required to be on call more than 8 days in one calendar month shall be compensated with one hour of time owed for each extra on call shift (i.e., each shift beyond 8 for the month).

### 8. Article XXVI - DURATION

Modify Article to state: "The terms and conditions of this Agreement shall become effective the first day of January 1, 2022, unless otherwise stated herein, and shall terminate at the close of business on December 31, 2029.

Prior to the roll call vote, Supervisor Schmitt explained that the Putnam County Sheriff's Department had been assisting pedestrians and valet drivers navigate Route 6 at the Villa Barone Hilltop Manor for many years. However, when their agreement was recently terminated, the operators of the event venue contacted the Town Board and asked them to consider allowing the Carmel Police Department provide the traffic control service. The Town Board discussed the matter with Police Chief Hoffmann and he recommended entering into the agreement out of an abundance of caution for public safety.

Supervisor Schmitt further explained that there will be no cost to the taxpayers for this service. Villa Barone Hilltop Manor, Inc. will reimburse the Town \$125 per hour per uniformed officer. This covers the actual cost of the officer's salary and benefits as well as the use of a marked car. They will also be providing insurance certificates.

Councilman Barile pointed out that this type of agreement is not exclusive to Villa Barone Hilltop Manor, Inc. The service can be provided to other venues as well.

# PUBLIC COMMENTS - AGENDA ITEMS

Erin Crowley, Mahopac resident, expressed her concerns with regard to the agreement with Villa Barone Hilltop Manor, Inc. She commented that the termination of the agreement between the Putnam County Sheriff's Department and the Villa Barone Hilltop Manor, Inc. was politically motivated.

Councilman Barile agreed that it was politically motivated. He stated, however, that the issue was between the Putnam County Legislature and the Putnam County Sheriff. He explained that the Town Board entered into the agreement to ensure the safety of the residents of the Town. Discussion ensued.

### PUBLIC COMMENTS - OPEN FORUM

Ms. Crowley commented on the litter she observed at the recent Farmer's Market in Mahopac and suggested that since State law bans single-use plastic bags, the vendors be asked to refrain from using them.

### TOWN BOARD MEMBER COMMENTS - AGENDA ITEMS

Supervisor Schmitt referenced a personnel item discussed by the Town Board earlier in Executive Session. Employee #1602 has been out recovering from a serious illness and Supervisor Schmitt explained that he is scheduled to retire on August 11, 2021. Because he is short of benefit time, four Highway Department employees have requested authorization to donate a total of three and one-half days which will allow the employee to remain out sick until the effective date of his retirement. Discussion held resulted in the addition of the following resolution.
