1. PAUL HARRIS - TM - 75.16-1-59: 15 ASTOR DRIVE - ELIGIBLE FOR A PERMIT - RETAIN STONE WALL

➤ Mr. Paul Harris of 15 Astor Drive, Mahopac appeared before the Board.

Chairman Laga said has anything changed on the application that you had previously submitted?

Mr. Harris said no.

Chairman Laga said we had no comments or questions from the public. You're putting a raingarden over here and then you're building a retaining stone wall right here in the middle with the raingarden in front of it. We didn't make you put in any silt fencing or anything.

Vice-Chairman Fannin said give me one moment to pull up my notes on this. You needed to include the 100' buffer on the actual map.

Chairman Laga said it's there.

Vice-Chairman Fannin said great; and then the raingarden calculations and layout on the plan. Where they were being placed, what they look like, that kind of thing.

Chairman Laga said I do not see the raingarden calculations.

Mr. Harris said (*inaudible*).

Chairman Laga said I see 6" deep, 1.5' wide by 30' long. I understand that but there's calculations that are associated with it.

Mr. Harris said (*inaudible - either mic not on or not near mic*).

Chairman Laga said I understand; I'm not worried. It's kind of like stone edge.

Vice-Chairman Fannin said how big is the raingarden?

Chairman Laga said 30' x 1.5'.

Vice-Chairman Fannin said that's fine.

Vice-Chairman Fannin moved to grant Permit #964 to Paul Harris of 15 Astor Drive, Mahopac NY as stated in the Permit with no additional conditions; seconded by Mr. Barnett with all in favor.
