**Response to ECB comments Duran, 928 Peekskill Hollow Road, Sports Court Construction
ECB meeting May 2020**

The only comment was to provide a mitigation plan for the disturbance within the wetland or wetland buffer.

The attached mitigation plan was prepared by Ted Kozlowski. The report has been converted to notes and placed on the plans.

WETLANDS MITIGATION PLAN

1. Inspection: The area between the brook and the concrete pad was inspected to formulate a mitigation plan. The berm along the east side of Peekskill Hollow Brook is existing and not well vegetated. The area between the berm and the pad is lawn.
2. The berm is to be scarified and extended along and out from the brook in the area as shown on this plan so it gradually levels off. Upon completion of the scarification it should be seeded with ERNST Raprian Buffer seed mix #178 at a rate of 20 lbs. per acre. The seed should be lightly covered with salt hay.
3. A tree planting zone must be created between the berm buffer and pad by planting a mix of 5 river birch trees (6 -10', B&B) and 6 bald cypress (6-10') in a staggered pattern at least 15 feet apart. Trees need to be well watered in and mulched with 2-3" of compost mulch. The plantings will serve to protect the berm and shade the brook.

Dear Mr. Karell:

At your request, I inspected the area between the brook and the concrete pad in order to formulate a mitigation plan. The berm along the east side of Peekskill Hollow Brook is created and not well vegetated. The area between the berm and the pad is lawn. Here are my recommendations:

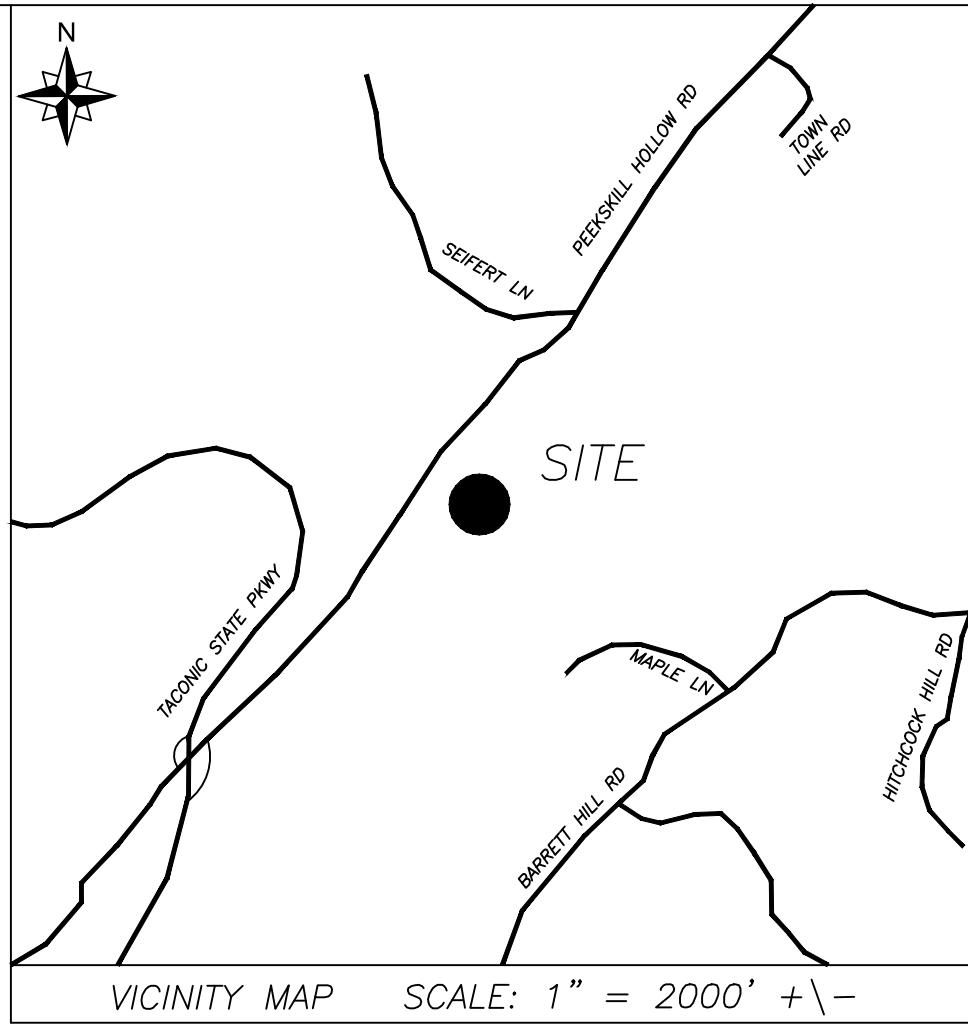
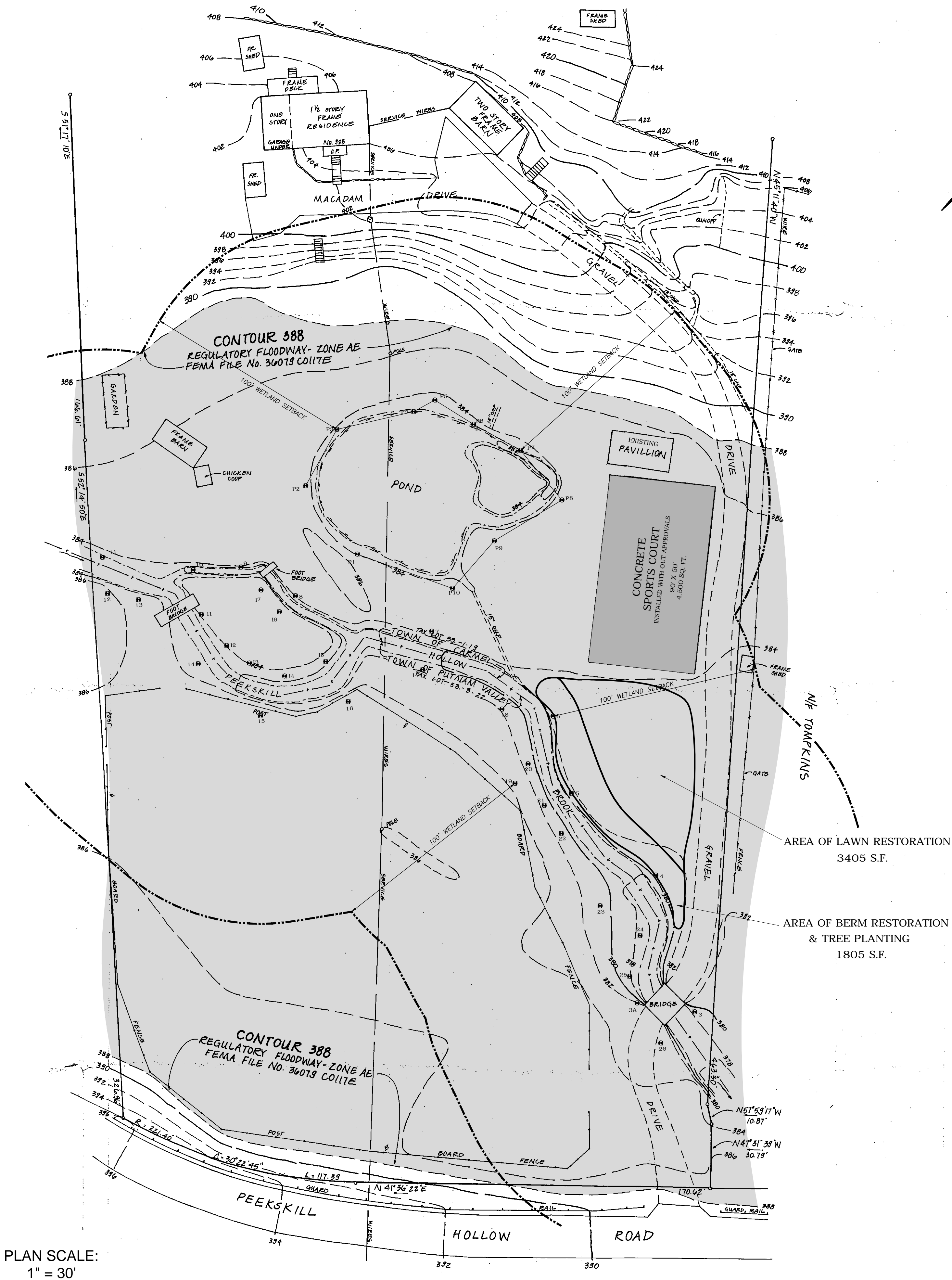
1. The berm should be scarified and extended out from the brook so it gradually levels off. Then it should be seeded with ERNST Raprian Buffer seed mix #178 at a rate of 20 lbs. per acre. The seed should be lightly covered with salt hay.
2. Create a tree planting zone between the berm buffer and pad by planting a mix of 5 river birch trees (6 -10', B&B) and 6 bald cypress (6-10') in a staggered pattern at least 15 feet apart. Trees need to be well watered in and mulched with 2-3" of compost mulch.

The plantings will protect the berm and shade the brook.
