SUPERVISOR'S FISCAL YEAR 2023 TENTATIVE BUDGET MESSAGE

Good evening everyone.

Tonight, I am honored to present my first Tentative Budget for Fiscal Year Ending 2023. First and foremost, I would like to thank everyone for all their help and support during my tenure as Town Supervisor; and although it has been a challenging year for all of us, I devoted much time and effort in the preparation of this budget to keep the cost to the taxpayers at a minimum.

Pursuant to New York State Town Law, Section 106, I present the 2023 Tentative Budget for your consideration and review. There were many factors to consider during the planning and preparation of this Tentative budget.

As a municipal Town, we must comply with the New York State Tax Cap which restricts the Town's overall growth in the property tax levy to 2% over the prior year's levy, or the rate of inflation; whichever is less.

I am very happy to report that Moody's investor services have maintained the Town's Aa1 credit rating. This allows the Town to borrow money for its capital projects at the lowest interest rates possible. I would like to acknowledge the Town's Comptroller, Mary Ann Maxwell, on receiving numerous Certificates of Achievements from the National organization representing Government finance professionals for transparency in financial reporting practices and Government accounting. These achievements compliment the Town's fiscal management and strong financial stability.

The Town will continue to provide a list of its essential information and services that is available both on the Town's Web page www.ci.carmel.ny.us and at all Town departments.

Again, this year, the Town Board offered a retirement incentive to uniformed members of the Police Department. Four members of the department with twenty (20) plus years of service, accepted the terms of the incentive and retired in 2022. These incentives resulted in a substantial savings to the resident taxpayers. Town Board hopes to continue offering the retirement incentive programs for our Police officers that result in a budget savings. The Police Department secured a grant for reinstatement of the K-9 program and I am happy to report that the Town has welcomed K-9 Officer Pietro, who will be graduating from the K-9 academy at the end of this year.

The Downtown Mahopac Revitalization Project, including the design of Swan Cove, as well as the Downtown Business District improvements are moving forward; this project will include parking for the business district. In July of 2022, the Town Board amended the Vehicle and Traffic Law changing Cherry Lane to a one-way street. I have also applied for a Revitalization Grant to fund the increase of municipal parking in both downtown hamlets.

The Town's Carmel Water District #2 Pipe Re-Lining Capital Project is near completion, and I am very happy to report that this capital project will finish under budget, at a cost savings of \$1.7 million dollars. The Town has actively lobbied Federal and State officials and applied for numerous grants to off set the costs related to the upgrading of the Town's infrastructure which includes the Town's Water and Sewer facilities. I am happy to report that the Town has applied for and received grant funding including \$3.7 million dollars of ARPA (American Rescue Plan Act) funds to help defray the costs of these projects.

In addition, and with the help and support of many Officials, employees and residents, the Town continues to move forward with the Town wide Comprehensive Master Plan, and Zoning Code. It continues to be a progress in the making; I am confident that upon its completion, the Comprehensive Plan and Zoning Code will greatly benefit the residents, business owners and tax payers.

My Tentative Fiscal Year 2023 Budget is subject to review and amendments made by the Carmel Town Board. Changes to the Tentative Budget may be made by the Board and a Preliminary Budget will be adopted on October 19, 2022. A Public Hearing on the Preliminary Budget will be held on November 9, 2022, at which time the Town Board will listen and take into consideration, public comments from the residents, business owners and tax payers. A Final Town wide Fiscal Year 2023 Budget must be voted on and adopted on or before November 20, 2022.

Since the onset of COVID, as with the residents, business owners and taxpayers, the Town continues to absorb the rising costs of insurances, utilities, materials, supplies and equipment; as well as having to deal with the frustration of their availability. As your Town Supervisor, I will put every effort into keeping the rising costs at a minimum and continue to lobby for funding through grants from the Federal and State Officials.

The 2023 Fiscal Year Tentative Budget reflects a 6.67% decrease in the Town wide tax rate.

To give you a comprehensive explanation of what this tax rate decrease actually means, our Town Comptroller, Mary Ann Maxwell will now present to you the Fiscal Year 2023 Town of Carmel Supervisor's Tentative budget. This presentation will provide for you an in-depth review and explanation of the Town's finances identifying projected expenditures and revenues for Fiscal Year 2023.

In closing, my sincere thanks to Town Comptroller, Mary Ann Maxwell, my Chief of Staff, Anne Pasquerello and Principal Office Assistant, Joanna Terilli, along with other elected officials, department heads and managers for their assistance and support during the preparation of my Tentative Budget, Fiscal Year Ending 2023.











 from capital project costs for the Water Meter and Water Storage Tank Projects. WMP was
 started in 2019 and is approx. 95% complete improving efficiency with the Town's billing process.
- <u>CWD #7</u> will see a special district tax increase due to need to reimburse General Fund Loan for emergency expenses in 2022.
- Contingent Line Budgeted \$100,000 in 2023 Tentative Budget.
- <u>Technology upgrades</u> \$70,000 is budgeted in the 2023 for technology upgrades. A fund was established for future purchase of *data imaging equipment Balance* \$105K.

EMPLOYEE/RETIREE BENEFITS COSTS 2014-2023




EMPLOYEE HI CONTRIBUTIONS 2014 - 2023



MORTGAGE TAX REVENUE








TOWNWIDE BUDGETED EXPENDITURES FOR FISCAL YEAR 2023 - \$32,105,595




TOTAL TAX BILL FOR TAXPAYER IN MAHOPAC CENTRAL SCHOOL DISTRICT






