He noted that towns are required under New York State law to maintain a Town Historian and encouraged residents who are interested in the position to contact his office for further information.

Supervisor Schmitt announced on behalf of the operators of the Ballad Barrett Cemetery in Mahopac Falls and the Presbyterian Church Cemetery at the corner of Route 6N and Secor Road that in an effort to keep their cemeteries active, they are urgently seeking members to serve on their board of directors. Interested residents may contact his office for further information. Discussion ensued.
