SIDE LETTER OF AGREEMENT

It is hereby agreed by and between the Town of Carmel (the "Town") and Local 456, I.B.T. (the "Association") as follows:

- A retirement incentive of \$20,000 shall be extended to all unit members, who meet all of the following conditions:
 - a. The submission of an irrevocable letter of resignation for purposes of retirement by the unit member with an effective retirement date no later than March 15, 2013, to be received by the Town Supervisor on or before the close of business on November 15, 2012;
 - Such unit member has fifteen (15) years of service with the Town and is eligible to retire under the New York State Employees' Retirement System; and
 - Such unit member shall retire in accordance with the New York State Employees' Retirement System as of the unit member's effective retirement date.
- Should an employee be eligible for the above retirement incentive, such payment shall be made payable within thirty days of the employee's effective retirement date.
- This incentive shall replace any and all prior retirement incentives offered by the town that may still be in effect.
- The retirement incentive shall be provided in lieu of any payout of leave accruals an
 employee would otherwise be entitled to upon retirement under the Association's
 Collective Bargaining Agreement.
- The retirement incentive shall not apply to unit members who have already submitted letters of resignation for purposes of retirement.
- This Agreement sunsets effective March 15, 2013, and shall be considered non-precedent setting and cannot be referred to by either party as evidence of a past practice.
- 7. This Agreement shall become effective upon the approval of the Carmel Town Board.

PUBLIC COMMENTS - AGENDA ITEMS

No member of the public wished to comment at this time.

TOWN BOARD MEMBER COMMENTS - AGENDA ITEMS

No member of the Town Board wished to comment at this time.

OPEN FORUM - PUBLIC COMMENTS

Peter Creegan expressed support of a comment made by a resident at the prior Work Session with regard to hiring part-time employees, rather than burdening the Engineering Department, to respond to questions pertaining to the new town-wide garbage collection program. He inquired if the Town does hire part-time staff, will they be provided with benefits.

Supervisor Schmitt stated that they will not.

Mr. Creegan asked if there was anything in writing that states that elected officials shall be provided with full-time benefits.

Councilman Lupinacci stated that it is included in the Town of Carmel Employee Handbook.

Mr. Creegan commented that it was deplorable that a CSEA member with over twenty-two years of service with the Town of Carmel was laid off to balance the budget. Discussion ensued.

Mr. Creegan expressed his frustration that members of the Town Board are offered fulltime benefits at a time when an employee is being laid off. He posed to the Town Board that they adopt a resolution at the commencement of 2013 stating that no parttime elected official shall receive full-time benefits.

Gregory Folchetti, Legal Counsel replied that such a change would have to be effective upon the commencement of an official's new term of office.

Supervisor Schmitt clarified that he receives his benefits as a retired Town of Carmel police officer.

Councilman Lupinacci noted that he receives his benefits through his full-time employment and elects not to participate in the Town's insurance.

Russ Braun voiced his agreement with Mr. Creegan with regard to his comments in connection with the layoff of a Town of Carmel employee. Mr. Braun then expressed his satisfaction with his current carter. He stated that they provide satellite pickup to the four homes on his right of way and after contacting the company awarded the contract for town-wide garbage collection, AAA Carting; he has yet to be advised as to how they will handle his service. He went on to state that the AAA Carting is not a union shop.

Councilman Lupinacci said that the employees must be paid prevailing wage.

Mr. Braun pointed out that there is a difference. He then spoke regarding the need for the posting of a traffic sign on Kennicut Hill Road to caution drivers about the upcoming turn on to Teakettle Spout Road.

Supervisor Schmitt stated that he would discuss the matter with Michael Simone, Highway Superintendent.

Don Schipf suggested that the vendors awarded the contracts for town-wide garbage collection pay the cost for hiring part-time personnel to respond to questions in connection with the program. He inquired about the amount being paid to the vendors.

(Cont.)

Councilman Lupinacci stated that the combined amount for the two companies awarded contracts will be \$2.6 million. He went on to point out that part-time staff or a consultant will only be retained during the implementation of the program, when an influx of inquiries is anticipated. When the operation is up and running, the carters will address the inquiries. A brief discussion regarding the matter ensued.

Mr. Schipf questioned if the employee being laid off has seniority over other employees.

Supervisor Schmitt indicated that the layoff was based on the title and job description, not length of service. Discussion was held with regard to the issue.

Mr. Braun asked if he can burn his garbage.

Supervisor Schmitt replied that he cannot. He indicated that it would be considered open burning which is not permitted in the Town of Carmel.

Mr. Braun asked if the Town inspects his neighbor's outdoor boiler which operates twenty-four hours a day, seven days a week.

Supervisor Schmitt explained that the Town of Carmel regulates outdoor wood boilers and if Mr. Braun chooses to do so, he may contact the Building Department with regard to his question. Discussion was held.

Mr. Schipf addressed an article that was published in January of 2012 which stated Moody's financial outlook of the Town of Carmel to be strong.

Supervisor Schmitt explained that a second review was preformed subsequent to that which indicated that although they maintained the Town of Carmel's strong bond rating of Aa1, they applied a negative outlook as a warning. He spoke regarding the importance of maintaining the Aa1 bond rating in connection with the Town's borrowing and discussion was held regarding the article.

OPEN FORUM - TOWN BOARD MEMBER COMMENTS

Supervisor Schmitt announced that the Hamlet of Carmel Civic Association will be holding their annual Menorah Lighting Ceremony on the shore of Lake Gleneida across from the Reed Library on December 10, 2012.

Supervisor Schmitt announced that the Italian American Club of Mahopac located at 141 Buckshollow Road is accepting donations for distribution to the victims of Superstorm Sandy through December 14, 2012.

Councilman Lombardi announced that on December 12, 2012 at 5:15 p.m. a walk will be held from the Temple Beth Shalom synagogue to the Mahopac Chamber Park for a public menorah lighting.

ADJOURNMENT

All agenda items having been addressed, on motion by Councilman Lombardi, seconded by Councilman Schneider, with all Town Board members present in agreement, the meeting was adjourned at 7:54 p.m. to Executive Session with the Chief of Police to discuss a personnel matter.
