	WHEREAS:				

- The New York State Department of Environmental Conservation ("DEC" or "Department") is responsible for the administration and enforcement of law and regulation pursuant to Article 40 of the New York State Environmental Conservation Law ("ECL").
- Respondent Town of Carmel Sewer District #2 ("Respondent") owns and/or operates a Chemical Bulk Storage facility (CBS #3-000339), which is located at 11 Old Route 6, Carmel, New York 10512 (the 'facility").
- On December 14, 2011 the Department documented violations at Respondent's facility.
 Specifically, Respondent violated:
 - A. 6 NYCRR Section 596.2(a)(2), which requires that registration of stationary storage tanks be renewed every two (2) years from the date of the last valid registration until the Department receives written notice that the storage tank has been permanently closed or that ownership of the storage tank has been transferred. Registration is required for any tank storing a hazardous substance which has the following total capacity: aboveground stationary storage tanks with a capacity of 185 gallons or greater and/or underground storage tanks of any capacity, and/or out-of-service storage tanks which have not been permanently closed. On the date of the inspection Department staff documented that the tanks were unregistered and therefore inaccurate due to Respondent's failure to timely renew the registration. The registration for Respondent's tanks 003, 004, 5A, and 6A expired on March 25, 2011 and the renewal was processed on January 10, 2012. Respondent had operated without proper registration of over 9 months.
 - B. 6 NYCRR Section 598.1(k)(1), which requires the owner or operator of any facility to prepare and maintain a Spill Prevention Report for preventing and responding to spills, releases and accidents at the facility, as well as to update the report at least annually or when a significant release occurs or a substantial modification is made. On the date of the inspection Department staff documented that compliant Spill Prevention Reports have not been updated annually.
 - C. 6 NYCRR Section 598.7(c)(2), which requires that an owner or operator conduct comprehensive annual inspections of the aboveground storage tank system. On the date of the inspection Department staff documented that Respondent failed to conduct comprehensive annual inspections of tanks 003, 004, 5A, and 6A. Specifically, both the annual visual inspections and the compliance review had not been performed in the manner consistent with the requirements of 6 NYCRR Section 598.7(c)(2).

- D. 6 NYCRR Section 598.7(d)(1), which requires that an owner or operator inspect aboveground piping systems and all above ground tanks every five years from the date of initial inspection. On the date of the inspection Department staff documented that Respondent failed to conduct the 5-year inspections of tanks 003, 004, 5A, and 6A.
- E. 6 NYCRR Section 599.17(c), which requires that transfer of hazardous substances must take place within a transfer station which is equipped with a permanently installed secondary containment system. On the date of the inspection Department staff documented that Respondent failed to install a transfer area secondary containment system.
- ECL Section 71-4303 provides for a civil penalty of up to \$25,000 for each violation of ECL.
 Article 40 or any rule or regulation promulgated thereunder.

NOW, having considered this matter and being duly advised, it is ORDERED that:

Civil Penalty.

Respondent is hereby assessed a civil penalty in the amount of Twenty thousand (\$20,000.00) dollars for the violations herein described, of which Seven thousand, five hundred (\$7,500.00) Dollars is payable and must be submitted with this Order bearing the signature of the Respondent. The remaining amount, Twelve thousand, five hundred (\$12,500.00) Dollars is hereby suspended provided Respondent strictly adheres to the terms and conditions of this Order, including the Compliance Schedule, attached hereto.

STANDARD PROVISIONS

<u>Payment</u>. Any penalty assessed pursuant to the terms and conditions of the Order shall be paid by submitting a certified or cashier's check or money order payable to the New York State Department of Environmental Conservation, with the Consent Order Number noted. If Respondent fails to make any payment by the date due, or Respondent shall otherwise be in non-compliance with this Order, the entire penalty amount remaining outstanding shall then become due and payable.

Communications. Except as otherwise specified in this Order, any reports submissions, and notices herein required shall be made to: Regional Engineer, Environmental Compliance Program, Department of Environmental Conservation - Region 3 Headquarters, 21 South Putt Corners Road, New Paltz, NY 12561.

<u>Effective Date</u>. This Order shall take effect when it is signed by the Regional Director, as the authorized representative of the Commissioner of Environmental Conservation, or his designee.

Access. For the purpose of monitoring or determining compliance with this Order, employees and agents of the Department shall be provided access to any facility, site, or records owned, operated, controlled or maintained by Respondent, in order to inspect and/or perform such tests as the Department may deem appropriate to copy such records, or to perform any other lawful duty or responsibility.

Force Majeure. If Respondent cannot comply with a deadline or requirement of this Order, because of an act of God, war, strike, riot, catastrophe, or other condition which was not caused by the negligence or willful misconduct of Respondent and which could not have been avoided by the Respondent through the exercise of due care, Respondent shall immediately notify the Department in writing, when it obtains knowledge of any such condition and shall request an appropriate extension or modification of the provisions hereof, Respondents will adopt all reasonable measures to prevent or minimize any delay.

<u>Indemnity</u>. Respondent shall indemnify and hold the Department, the State of New York, their representatives, employees, agents and contractors harmless for all claims, suits, actions, damages and costs, of every nature and description, resulting from the acts and/or omissions of Respondent, intentional, negligent, or otherwise, of every nature and description, arising out of or resulting from the compliance or attempted compliance with the provisions of this Order by Respondent or its employees, servants, agents, successors (including successors in title) or assigns.

Modifications. No change in this Order shall be made or become effective except as specifically set forth by written order of the Commissioner.

Reservation of Rights. Nothing contained in this Order shall be construed as barring, diminishing, adjudicating or in any way affecting (1) any legal, administrative or equitable rights or claims, actions, suits, causes of action or demands whatsoever that the Department may have against anyone other than Respondent; (2) any right of the Department to enforce administratively or at law or in equity, the terms, provisions and conditions of this Order; (3) any right of the Department to bring any future action, either administrative or judicial, for any other violations of the ECL, the rules and regulations promulgated thereunder, or conditions contained in orders or permits, if any, issued by the Department to Respondent; (4) the summary abatement powers of the Department, either at common law or as granted pursuant to statute or regulation

Entire Agreement. This Order shall constitute the entire agreement of the Department and Respondent with respect to settlement of the violations specifically referenced herein

<u>Binding Effect</u>. The provisions, terms, and conditions of this Order shall be deemed to bind Respondent, Respondent's heirs, legal representatives, receivers, trustees in bankruptcy, successors and assigns.

Service. If Respondent is represented by an attorney with respect to the execution of this Order, service of a duly executed copy of this Order upon Respondent's attorney by ordinary mail shall be deemed good and sufficient service.

Multiple Respondents. If more than one Respondent is a signatory to this Order, use of the term "Respondent" in these Standard Provisions shall be deemed to refer to each Respondent identified in the Order.

SUPERVISOR'S 2013 TENTATIVE BUDGET MESSAGE

Good evening ladies and gentlemen, members of the Town Board, residents of the Town of Carmel. As required by Town Law of the State of New York, I hereby submit the Tentative Budget for the Town of Carmel for Fiscal Year 2013.

As the Town of Carmel and our entire nation continues to cope with the ongoing economic and fiscal challenges that have created tremendous hardships for many of our residents and business owners, rest assured that I, along with my colleagues on the Carmel Town Board, will continue to be fiscally responsible stewards of your tax dollars. The Town Board and I are committed to exploring and seeking all possible cost cutting initiatives in an effort to reduce the Town's overall operating expenditures thus providing tax relief for our residents and property owners.

Looking forward, the most significant challenges are not only balancing the needs of the community, but also responding to the continued economic conditions. To meet the challenges, the Town must anticipate necessary expenditures and create efficiencies to ensure that service delivery is equitable, fair and at a reasonable cost. The Town must create a prudent financial plan that reflects the vision and values of the people of the Town of Carmel.

(Cont.)

The 2013 town wide operating budget has been particularly challenging due to significantly increasing costs. Low and declining revenues and unfunded mandates both on the State and Federal levels have created substantial budget difficulties. The Town's largest source of revenue, Mortgage Tax, has remained very low due to the weak and stagnant housing market. Since 2008, the Town has experienced major increases in NYS Pension Plan contributions, health insurance premiums have increased steadily. These along with premium increases for Workers Compensation Insurance have had a significant impact on the Budget. For example, in the 2013 Budget, the costs for Pension Plan, FICA, Medicare, MTA Tax, Workers Compensation and Health Insurance account for 29 cents out of every dollar.

It is important to note that the 2013 Budget was prepared without utilizing any monies from the Town's Reserve Fund Balance. This is significant because recently the Town's finances were reviewed by Moody's, a Financial Rating Agency. Although Moody's confirmed the Town's AA1 Bond rating, a negative outlook was added to the Town's Bond rating. What does this mean? The negative outlook reflects the trend of deteriorating fund balances, and lower

reserve levels. The Town's rating going forward will depend on management's ability to stabilize the Town's finances without further deterioration in operations.

The 2013 Tentative Budget reflects an 8.7% increase in the Town wide tax rate. The Town wide taxes for the typical homeowner assessed at \$216,000 will be a \$125 increase over the 2012 Budget.

In Summary: The 2013 Budget was perhaps the most difficult and challenging process by all those involved. Unpleasant decisions, perhaps unpopular ones, had to be made. The Town of Carmel is committed to providing its residents with a continued level of professional service while remaining cognizant of the extremely difficult economic times.

In closing, my sincere thanks to Town Comptroller, Mary Ann Maxwell, my office staff, Anne Pasquerello and Bella Cimadomo, along with other elected officials, department heads and managers for their diligence and assistance during the preparation of this document.

Lastly, I would like to express my thanks to the residents of the Town of Carmel and those affected by the budget cuts for their patience and understanding as we move forward through these difficult economic times that we are all living in.

Tax Levy vs. Tax Rate

- Property Tax Levy is the total amount of money to be raised by taxes to cover the cost of providing services to the public.
- The annual levy is calculated by taking the Town's total annual expenditures less any revenues and/or appropriated fund balance equity. Expenditures
 - Revenues
 - +(-) Appropriated Fund Balance
 - = Property Tax Levy

Tax Levy vs. Tax Rate

 The annual <u>Tax Rate</u> is determined by dividing the total amount of the <u>property tax levy</u> by the total <u>taxable</u> <u>assessed value</u> of a town or special district.

Property Tax Levy / Taxable Assessed Value

- = Annual Tax Rate
- The taxable assessed value is determined annually by the Town Assessor.
- The town wide taxable assessed value used for the 2013 Budget is 2,642,509,380, a decrease of approximately \$14 Million from the 2012 taxable assessed value.

2013 Tentative Budget

- Townwide (General/Highway) the average homeowner (\$216,800 assessed value) would pay approximately \$1,614 per year (an increase of \$125) from the prior year.
- Approximately \$7,062,303 is budgeted in 2013 for Employee Benefit Costs. This includes Pension Costs, Workers Comp Ins, Health Benefit Cost, FICA/Med/MTA Tax. Next year the town will pay approximately \$0.29 cents on every dollar to fund the benefit costs of town wide employees and retirees.

MOODY'S REVIEW

- Last month Moody's confirmed the Town's Aa1 Bond rating with a negative outlook.
 - "The revision of the outlook reflects the trend of deteriorating fund balances and lower reserve levels. The direction of the rating going forward will hinge upon management's ability to stabilize the town's finances".
- Fund Balances have deteriorated substantially since 2007 from \$8.2M to \$3.1M for Fiscal Year End 2011.
- \$0 Fund Equity is being appropriated in 2013 Tentative Townwide Budget.

MULTI-YEAR FINANCIAL PLANNING

- The Town Comptroller and Town Board are currently working on a <u>4 Yr Multi-Year Financial Plan.</u>
- This plan covers a nine year period, going back four years to 2008, and projecting revenues, expenditures and fund equity through the year 2016.
- Based on a preliminary look at this plan, unless revenues increase, the Town would need to continue increasing taxes over the next few years in order to <u>fund current staff levels and</u> continue to provide the services currently offered.


MULTI-YEAR FINANCIAL PLANNING

- A Multi-Year Capital Plan to include a Vehicle Replacement Plan for Police Cars and Highway Machinery & Equipment is also being discussed.
- Six new highway trucks were purchased this year, which we will be required to pay interest on in 2013.
- Purchased new Vac All Truck at <u>no</u> cost to the taxpayers for \$250,000 through NYCDEP/East of Hudson Watershed Protection Funding.
- Purchased used 2009 bucket truck for \$115,000 in excellent condition for use by our Town Highway Tree Crew. If purchased new the cost for this truck would have been \$250,000.




Employee Benefits Cost Increases 2009-2013







Mortgage Tax Revenue History






Town of Carmel Decreasing Fund Equity




2013 Special District Budgets

- Approved a \$2.2 Million dollar water main replacement project for CWD #8. Construction to begin shortly. Will be required to pay interest on debt in 2013.
- Currently reviewing the Water Rents the Town charges which have not been increased since 2003. Many rates will increase which will result in many taxes decreasing. Currently approximately 60-80% of our expenditures in the Water Districts are funded through taxes not water rents.
- Most of the Special Districts Assessed Values used to prepare the 2013 Budget have decreased due to certiorari settlements, small claims and corrections of errors on assessments.
- Many special district taxes will increase due to the decrease in assessed value from the prior year.

Councilwoman McDonough requested clarification with regard to the \$.4 million Community Services budget line listed under the Total 2013 Appropriations by Fund.

Ms. Maxwell explained that it includes the various boards serving the Town, cemetery repair, museum expenses as well as the salary and benefits of a recycling employee. She added that it also includes funding to the American Legion, Veterans of Foreign Wars and the Garden Club.

Councilman Lombardi commended Supervisor Schmitt and Ms. Maxwell for their hard work with regard to the 2013 Tentative Budget. He acknowledged Ms. Maxwell's informative PowerPoint presentation.

Councilman Lombardi went on to express his frustration with New York State's 2% property tax cap and exorbitant unfunded mandates. He spoke regarding his efforts to cut expenditures during the course of his tenure on the Town Board. Councilman Lombardi concluded that the Town Board will continue to work on the 2013 Budget and when adopted, it will be fair to the public and will provide a positive financial outlook for the Town.

Ms. Maxwell stated that the annual review of the User Fee Schedule has commenced and upon her recommendation, now coincides with the budget process in an attempt to locate areas to increase revenue.

Councilman Lupinacci pointed out that the proposed 8.7% increase does not apply to the total property tax bill. It applies only to the 11% paid in connection with the Town's portion.

Supervisor Schmitt added that the school's portion of a property tax bill amounts to approximately 68%. He commented that although he is not particularly happy with a tax increase of 8.7%, he is comfortable with it because it is a realistic Budget. Supervisor Schmitt spoke regarding the budget process and encouraged the public to weigh in on it.

Councilman Lupinacci addressed the importance of public participation throughout the budget process.

Supervisor Schmitt announced that copies of his 2013 Tentative Budget and Ms. Maxwell's PowerPoint presentation will be available in the Town Clerk's office as well as online at the Town of Carmel's Website.

PUBLIC COMMENTS - AGENDA ITEMS

No member of the public wished to comment at this time.

TOWN BOARD MEMBER COMMENTS - AGENDA ITEMS

No member of the Town Board wished to comment at this time.

OPEN FORUM - PUBLIC COMMENTS

Anita Olivier inquired if all Town Board members were aware of a complaint made with regard to the Town of Carmel's lack of compliance with Americans with Disabilities Act (ADA) regulations.

Supervisor Schmitt indicated that they were all aware of the complaint. He went on to provide an update with regard to renovations to the Town Hall building currently under way to bring the facility into compliance with ADA standards which include new remote doors and handicap accessible bathrooms. Supervisor Schmitt apologized for any perceived delays.

Ms. Olivier commented that residents may not be attending Town Board meetings because they feel that the Town Board is already in agreement about every issue.

Supervisor Schmitt stated that the Town Board does disagree from time to time. Discussion ensued.

Ms. Olivier commented that when viewing the Town Board meetings on cable television, the public has no indication when the meetings have taken place. She suggested time stamping the videos of future meetings.

Councilman Lombardi replied that the issue could be easily rectified.

OPEN FORUM - TOWN BOARD MEMBER COMMENTS

Supervisor Schmitt announced that the Carmel Town Hall will be closed on October 8, 2012 in observance of Columbus Day.

Supervisor Schmitt announced that there will be a guided bus tour of Carmel's most interesting and historical cemeteries on October 20, 2012 beginning at 10:00 a.m. Further information may be obtained from Brian Vangor, Town Historian at carmelhistorian@gmail.com.

Councilman Lupinacci provided an update with regard to the prospect of town wide garbage collection. He indicated that the advertising for bids for the contract has commenced, a pre-bid meeting was held and the bid opening will be conducted on October 17, 2012.

Supervisor Schmitt spoke regarding the recent Lake Mahopac Garden Club flower show which was held at Sycamore Park. He commended the members for their outstanding designs and horticulture as well as for all that they do to beautify the community.

Supervisor Schmitt acknowledged the Italian American Club of Mahopac for their efforts with regard to the Putnam County Columbus Day parade and their annual Evening at the Piazza event. He also recognized the Greater Mahopac-Carmel Chamber of Commerce with regard to their annual street festival which was held in conjunction with the parade.

ADJOURNMENT

All agenda items having been addressed, on motion by Councilman Lombardi, seconded by Councilwoman McDonough and Councilman Lupinacci, with all Town Board members present and in agreement, the meeting was adjourned at 8:19 p.m. to Executive Session to discuss a matter of personnel with the Town's legal labor counsel as well as a Lieutenants Union negotiation update from Councilmen Lombardi and Lupinacci.
