IT IS HEREBY STIPULATED AND AGREED, by and between the undersigned, the attorneys for all parties and the parties to the above-entitled action, that whereas no party hereto is an infant or incompetent person for whom a guardian has been appointed and no person not a party has an interest in the subject matter of the action, this proceeding the following shall constitute the settlement and disposition of this matter:

That all right, title and interest to a certain parcel of real property being contiguous to
the westerly boundary of the Plaintiff's property at 223 Austin Road in the Hamlet of Mahopac,

Town of Carmel, Putnam County, New York, said certain parcel formerly comprising a portion of the Defendants' premises at 15 Shepard Lane (also known as 225 Austin Road) in the Hamlet of Mahopac, Town of Carmel, Putnam County, New York, and designated as Tax Map Number 64.17-1-14 in said Town, shall immediately upon the execution of this Stipulation and Order vest in Plaintiff MAUREEN KRAUSS. Said certain parcel of real property is hereafter referred to herein as the "subject property" and is more particularly bounded and described as follows:

ALL that certain plot, piece or parcel of land situate in the Town of Carmel, County of Putnam, State of New York, bounded and described as follows:

BEGINNING at a point on the southerly line of Austin Road distant 129.93 feet on a course S.69°51'55" E. from a concrete monument found marking the northwest corner of a 30 ft. wide right of way and the northeast corner of lands now or formerly of Fiona Graham as described in Liber 1049, Page 7 of Deeds; thence running from said point and place of beginning, along the existing westerly line of record of the lands conveyed to Frank P. & Maureen Krauss as described in Liber 1097, Page 292 of Deeds,

- That upon said execution of this Stipulation and Order, Plaintiff MAUREEN
 KRAUSS shall be the owner in fee simple and seized and possessed of the subject property.
- That any claim which the Defendants have or might claim to have to the subject property is without validity and of no force and effect.

- 5. That upon said execution of this Stipulation and Order, Plaintiff's westerly-most property line at the premises located at 223 Austin Road in the Hamlet of Mahopac, Town of Carmel, Putnam County, New York shall be deemed to be re-located and adjusted to the westerly-most line of the subject property being conveyed under this Stipulation and Order. Thereafter Plaintiff's property, 223 Austin Road in the Hamlet of Mahopac, Town of Carmel, Putnam County, New York shall hereinafter and in perpetuity be bounded and described as follows:

ALL that certain plot, piece or parcel of land situate in the Town of Carmel, County of Putnam, State of New York, bounded and described as follows:

BEGINNING at a point on the southerly line of Austin Road distant 129.93 feet on a course S.69°51'55" B. from a concrete monument found marking the northwest corner of a 30 ft. wide right of way and the northeast corner of lands now or formerly of Fiona Graham as described in Liber 1049, Page 7 of Deeds; thence running from said point and place of beginning, along the southerly line of Austin Road,

S. 69°13'20" E. 22.14 feet and S. 66°37'10" E. 89.30 feet

to a point of curvature; thence continuing along the southerly line of Austin Road on curve to the right having a radius of 220.59 feet and a central angle of 13°19'40" an arc length of 51.31 feet to the lands now or formerly of Weiss & Rosenweig as described in Liber 838, Page 20 of Deeds; thence turning and running along said lands now or formerly of Weiss & Rosenweig,

to the proposed new division line between lands of Krauss and lands now or formerly of New Hill Homes, Inc.; thence running along said proposed new division line between lands of Krauss and lands now or formerly of New Hill Homes, Inc.,

N. 11°00'55" E. 125.61 feet, N. 68°50'00" W. 4.00 feet, N. 16°20'00" E. 39.60 feet, N. 24°23'00" E. 32.00 feet and N. 25°25'00" E. 53.80 feet

to the southerly line of Austin Road and the point and place of beginning.

SUBJECT to easements, rights of way, covenants and restrictions of record, if any, and to any state of facts that a complete survey and examination of title may disclose.

6. That the Town of Carmel stipulates and agrees that no area variances shall be required due to the change in lot lines effected by this Stipulation and Order with regard to the existing structures on the property located at 15 Shepard Lane (also known as 225 Austin Road) in the Hamlet of Mahopac, Town of Carmel, Putnam County, New York, and designated as Tax Map

Number 64.17-1-14 in said Town. The structures that exist on said parcel as of the date of this Stipulation and Order shall be deemed in compliance with the Town of Carmel's zoning requirements. After the lot line adjustment as set forth in this Stipulation and Order, the distance from the existing structures and the eastern lot line of said parcel shall be deemed to be in compliance with all zoning requirements of the Town of Carmel.

- 7. Within 90 days of the date of this Stipulation and Order, the Plaintiff shall replace the entire length of fence located on the westerly side of the Plaintiff's property. The fence shall not be installed any further than one foot from the end of the asphalt drive existing on the Plaintiff's parcel as of the date of this Stipulation and Order, and in no case the fence shall be located within the Plaintiff's property line as set forth in this Stipulation and Order. The Plaintiff shall replace the fence with a new fence, the material and design of which shall be subject to the approval of the Defendant New Hill Homes, Inc., which approval shall not be unreasonably withheld, it being understood by the parties that the aesthetic nature of the fence may have a direct impact on the value of the Defendant's parcel and upon the use and enjoyment thereof. The fence that is installed by the Plaintiff shall meet all requirements of the Town Code of the Town of Carmel.
- 8. With respect to any relocation, reconfiguration and/or modification of lot lines of either parcel belonging to Plaintiff or Defendant as referenced herein, which may created by this Stipulation and Order, all requirements of the Town of Carmel Town Code, Chapter 131 entitled "Subdivision of Land" of the Carmel Town Code, are hereby deemed satisfied. The relocation, reconfiguration and/or modification of lot lines of said parcels shall be deemed a legal subdivision of land.
- 9. That this Stipulation and Order, or a certified copy thereof, shall be immediately indexed in the Office of the Clerk of the County of Putnam land records against the respective premises of each of the parties herein.
- 10. That subsequent to said filing of this Stipulation and Order a copy of same shall be delivered to the Real Property Tax Department of the County of Putnam, which is ordered and directed to immediately revise, adjust and/or modify its records concerning the affected properties of the parties herein and described above in accordance with the express terms of this Stipulation and Order.
- 11. That subsequent to said filing of this Stipulation and Order a copy of same shall be delivered to the Office of the Tax Assessor of the Town of Carmel is ordered and directed to

JUSTICE OF THE SUPREME COURT

Gregory Folchetti, Legal Counsel explained that the settlement involves the two private parties to the original action agreeing upon a revised common lot line and description, with monetary consideration being paid in connection therewith. With respect to the Town of Carmel, no consideration is to be paid by the Town in exchange for the discontinuance of the second action commenced against it by Krauss. The stipulation will be ordered by the Court once signed and will provided for the legal subdivision of the parcel and conformance to any and all side yard setback requirements in the Zoning Code, which is needed because the Town Code does not contain a lot line adjustment provision.

FORMATION AND CONSENT TO BECOME MEMBER OF EAST OF HUDSON WATERSHED CORPORATION - AUTHORIZED

WHEREAS, the Town of Carmel is a member of the East of Hudson Coalition ("EOH Coalition"), an association of municipalities located in the New York City watershed east of the Hudson River ("EOH Watershed"); and

WHEREAS, the Town of Carmel and the other members of the EOH Coalition are individually subject to General Permit GP-0-10-002 for Municipal Separate Storm Sewer Systems ("MS4 Permit"), pursuant to which municipalities are required to implement storm water retrofits and encouraged to participate in a regional storm water retrofit plan; and

WHEREAS, the EOH Coalition was successful in negotiating on behalf of its members Special Condition 34 of the Water Supply Permit issued by the Department of Environmental Conservation ("NYSDEC") on December 24, 2010 ("2010 WSP"), which requires New York City (the "City") to provide \$15.5 million to the EOH communities to help fund implementation of their regional storm water retrofit plans; and

WHEREAS, the EOH Coalition has negotiated an agreement with the City (the "Funding Agreement") which will enable the City to transfer the \$15.5 million provided for in the 2010 WSP and the \$4.5 million provided for in the 2007 Filtration Avoidance Determination ("2007 FAD") to the EOH communities; and

WHEREAS, the 2010 WSP encouraged the formation of a regional storm water entity ("RSE") to organize, administer and implement the storm water retrofit projects, by providing that up to \$50,000 of the \$15.5 million could be used by the EOH communities for the formation of the RSE; and

WHEREAS, the EOH Coalition has drafted articles of incorporation and bylaws for an RSE, which have been favorably reviewed by NYSDEC and the City, to be known as the East of Hudson Watershed Corporation ("EOH Watershed Corporation"), the members of which would be the municipalities located in the EOH Watershed and the Board of Directors of which would be the chief elected officials of the members; and

WHEREAS, the execution of the Funding Agreement and the payment of the \$15.5 million by the City under the Funding Agreement cannot occur until the EOH Watershed Corporation is formed; and

WHEREAS, it is in the best interest of Town of Carmel to authorize the formation of and become a member of the EOH Watershed Corporation for the purpose of jointly organizing, administering and implementing the regional storm water plans under the MS4 Permit;

NOW THEREFORE BE IT RESOLVED, that Town of Carmel authorizes the formation of and consents to be a member of the EOH Watershed Corporation, with articles of incorporation and bylaws substantially in form and substance as annexed hereto; and

BE IT FURTHER RESOLVED, that Kenneth Schmitt, the Supervisor of the Town of Carmel is hereby designated to serve as the initial member of the Board of Directors of the EOH Watershed Corporation as provided in said articles of incorporation and bylaws.

Supervisor Schmitt stated that the aforementioned resolution formalizes the name change from the East of Hudson Coalition to the East of Hudson Watershed Corporation.

ENTRY INTO FUNDING AGREEMENT ON BEHALF OF THE EAST OF HUDSON WATERSHED COMMUNITIES - APPROVED AND RECOMMENDED

WHEREAS, the Town of Carmel is a member of the East of Hudson Coalition ("EOH Coalition"), an association of municipalities located in the New York City watershed east of the Hudson River ("EOH Watershed"); and

WHEREAS, the Town of Carmel and the other members of the EOH Coalition are individually subject to General Permit GP-0-10-002 for Municipal Separate Storm Sewer Systems, pursuant to which municipalities are required to implement stormwater retrofits and encouraged to participate in a regional stormwater retrofit plan; and

WHEREAS, the EOH Coalition was successful in negotiating on behalf of its members Special Condition 34 of the Water Supply Permit issued by the Department of Environmental Conservation on December 24, 2010 ("2010 WSP"), which requires New York City (the "City") to provide \$15.5 million to the EOH communities to help fund implementation of their regional stormwater retrofit plans; and

WHEREAS, the EOH Coalition has negotiated a draft agreement with the City (the "Funding Agreement") which will enable the City to transfer the \$15.5 million provided for in the 2010 WSP and the \$4.5 million provided for in the 2007 Filtration Avoidance Determination to the East of Hudson Watershed Corporation, when formed; and

WHEREAS, upon formation of the East of Hudson Watershed Corporation, the Board of Directors thereof will have the responsibility of reviewing and approving the final draft of the Funding Agreement; and

WHEREAS, it is in the best interest of the Town of Carmel to have the East of Hudson Watershed Corporation enter into the final draft of the Funding Agreement on behalf of the EOH Watershed communities;

NOW THEREFORE BE IT RESOLVED, that the Town of Carmel approves the Funding Agreement and recommends to the Board of Directors of the East of Hudson Watershed Corporation, when formed, that the Corporation enter into the Funding Agreement substantially the same in form and substance as the July 12, 2011 draft.
